Sub: Filling up the posts of Stenographer Grade 'D' and Dispatch Rider in the National Human Rights Commission on direct recruitment basis.

Applications are invited from candidates fulfilling the eligibility conditions as mentioned at **Annexure-I** for appointment to the above mentioned posts in the National Human Rights Commission on direct recruitment basis.

**Number of vacancies:** Number of vacancies and reservations available are mentioned in Annexure-I.

**Mode of Recruitment:**

**I:- Steno Grade 'D' (Reserved for Ex-servicemen only)**

- (a) Written Examination (objective type) – 200 marks (General Intelligence & Reasoning -50 Marks, General Awareness – 50 Marks and English Language and Comprehension – 100 marks)

Duration: 2 hours (2 hours and 40 minutes for Visually handicapped candidates)

- (b) Skill test in Stenography:- Dictation for 10 minutes in English/Hindi at the speed of 80 wpm  
Transcription time: 50 Minutes (English)  
65 Minutes (Hindi)

Visually handicapped persons- 75 minutes (English)—100 minutes (Hindi)

**II:- Dispatch Rider**

Skill Test (driving test) followed by Interview

**Fee:** (i) For the post of Stenographer Grade 'D' Ex-servicemen are exempted for payment of examination fee.

- (ii) For the post of Dispatch Rider:-  
**Rs.100/- (Rupees one Hundred only) payable through Demand Draft/Bankers Cheque drawn on "NATIONAL HUMAN RIGHTS COMMISSION".** Fee is exempted for all women candidates and candidates belonging to Scheduled Caste, Scheduled Tribe, Physically Handicapped categories. Fee once paid will **not** be refunded under any circumstances.


**Examination Centre:** The examination will be conducted in Delhi only. Date of examination shall be intimated to the eligible candidates separately. The Commission will not pay any TA/DA to the candidates for attending the Written Examination and Skill Test.

**How to apply:** The candidates fulfilling the eligibility conditions as mentioned in **Annexure-I** may apply in the prescribed format as per **Annexure-II** by post to the **Under Secretary (Estt), National Human Rights Commission, Manav Adhikar Bhawan, Block-C, GPO Complex, INA, New Delhi-110 023**, along with copies of relevant supporting self attested documents like proof of age, qualification, category certificate, disability certificate etc.

The applications without supporting documents, photograph, unsigned and incomplete applications, in any manner, shall be summarily rejected.

The candidates who are already in Government Service should apply through proper channel failing which the applications shall not be considered.

**Closing date :** The last date of receipt of application will be within 30 days from the date of publication of advertisement in Employment News and newspapers.
