The National Human Rights Commission has a scheme of engagement of Special Rapporteurs to "examine, monitor, evaluate, advise and report" on human rights problems through "activities undertaken by special procedures, conducting visits and providing advice on emerging issues from the perspective of human rights. In accordance with the above scheme, the Commission proposes to engage Zonal Special Rapporteurs for the following Zones.

| 3. | Central-I    | Madhya Pradesh, Chattisgarh and Rajasthan.   |
| 4. | South-1      | Tamil Nadu, Poduchery, Kerala and Lakshadweep.   |
| 5. | South – 2    | Andhra Pradesh, Telengana and Karnataka  |
| 6. | North East   | Assam, Meghalaya, Manipur, Arunachal Pradesh, Nagaland, Mizoram, Sikkim and Tripura    |

The Commission also proposes to prepare a panel of experts for engagement as thematic Special Rapporteurs on various emerging human rights issues, from which they may be engaged on need basis from time to time.

Application inscribing "Zonal Special Rapporteurs" or "Thematic Special Rapporteurs" or "both" may be sent separately.

**Those who have already applied are requested to apply afresh.** Application not in the prescribed proforma or incomplete applications are liable to be summarily rejected.


