Sub:- Interview for engagement of Interns on contract basis in the National Human Rights Commission – List of short listed candidates for the personal interview

In continuation to the Commission's notification of even number dated 11<sup>th</sup> May, 2016 inviting applications of eligible candidates for engagement as Interns on contract basis, a list of short listed candidates for the **personal interview scheduled on 30.08.2016 and 31.08.2016** is given in Annexure-I, Annexure-II and Annexure-III. The interview shall be held in the Commission's above address. Since the response was overwhelming as more than 600 applications have been received, the candidates for the personal interview have been shortlisted on the basis of their aggregate percentage of marks in 5 year integrated LLB course/3 year Graduation + 3 year LLB course, as the case may be, as has already mentioned in the notification.

The short listed candidates shall be required to bring following original documents along with one self attested photocopy while attending the interview. (i) Identity Card (Pan Card/Adhar Card/Election ID Card/DL etc.), (ii) certificate showing date of birth, (iii) LLB final mark list showing percentage of marks, (iv) LLB Degree Certificate and (v) Degree certificate and mark sheets. Wherever CGPA/CPI/FGPA grades are mentioned in the mark sheets, documentary proof of norms adopted by the Institute/University to convert CGPA/CPI/FGPA to percentage needs to be submitted. The onus to submit documentary proof of obtaining an aggregate of 70% or marks in 5 year integrated LLB/ Graduation + 3 year LLB course shall be with the candidates and candidates who do not have the above percentage or do not have final mark sheets and Degree certificates need not come to the interview as they shall not be allowed to attend the same.

2. The shortlisted candidates are requested to report at the above address **one hour before the scheduled time of interview on 30.08.2016 and 31.08.2016**. No separate call letters shall be sent to the short listed candidates.
3. Attending the personal interview shall not confer any right for appointment as Intern on contract basis in the Commission.
4. Kindly note that **no TA/DA** will be paid by the Commission for attending the interview.
