**WALK-IN-INTERVIEW FOR ENGAGEMENT OF JUNIOR RESEARCH
CONSULTANTS ON SHORT TERM CONTRACT BASIS
IN THE NATIONAL HUMAN RIGHTS COMMISSION**

The National Human Rights Commission requires the services of persons who fulfill the following criteria and who have knowledge and aptitude for research and practical experience in dealing with human rights issues for engagement as Junior Research Consultant on short term contract basis for a period of three months.

2. The eligibility criteria, consolidated remuneration and other conditions of the contractual engagement are given hereunder:-

Junior Research Consultant – 3 Nos.

Eligibility criteria	Persons having a Post Graduate Degree in Political Science/Sociology/Social Work/Economics/ Human Rights / Psychology/ Population Studies or Criminology from any recognized University with minimum 60% marks
Age limit	Maximum 30 years of age as on the last date of receipt of application
Period of short term contract	Three months.
Remuneration	Rs.30,000/- per month


3. The appointment will be purely on contract basis for a period of three months. The candidates will have no right to claim for any regular employment in the Commission.

4. Eligible and interested candidates may send their Bio-Data in the enclosed proforma by e-mail to nhrcestt@nic.in before **5.00 P.M. on 21st April, 2016**. Details of short listed candidates for the walk-in-interview shall be displayed in the website of the Commission nhrc.nic.in on **25th April, 2016**. In case number of candidates is higher, the Commission reserves the right to short list the candidates on the basis of marks obtained.

5. The "**walk-in-Interview**" of the short listed candidates shall be held **at the above address of the Commission on 26th April, 2016 at 11.00 A.M to 4.00 P.M.** The short listed candidates should bring attested copies of (i) Identity Card (Pan Card/Adhar Card/Election ID Card/DL etc.), (ii) certificate showing date of birth and educational qualifications and (iii) one passport size photograph while attending the interview. In the event of selection, their engagement shall be subject to verification of all original documents.

6. No TA/DA shall be paid for attending the Walk-in-interview.
