## At NHRC, Shah says don't apply western norms of rights here

HOME MINISTER Amit Shah on Saturday said that India's human rights policy must focus on the rights of civilians killed by militants or Maoists as much as it does on police atrocities and custodial deaths.


"There is no bigger violation of human rights than those affected by militants in Kashmir or Naxals. We must look at these issues with an Indian outlook," Shah said, while speaking at the 26th foundation day of the National Human Rights Commission (NHRC).

Shah, who was the chief guest at the event, said that western standards of human rights cannot be blindly applied to Indian issues. "Women not having access to toilets and safe methods of cooking is a human rights issue. Modi government has ensured upliftement of millions of individuals from these situations," he said, enumerating the government's efforts at increasing the standard of living.

The Union minister said that under Prime Minister Narendra Modi's leadership, India is moving towards a scenario where there will be no human rights violations.

"India has an inbuilt framework of human rights. Our family values have special protection of women and children, and villages look after the poor believing it to be part of their dharma," he said.

NHRC chairperson and former

Chief Justice of India HLDattu said that the government has supported the commission in fulfilling its mandate. "The Home Minister's presence is a source of encouragement to NHRC," he said.

Dattu added that the NHRC has fulfilled its mandate by tackling pressing issues related to bonded labour and custodial deaths.

According to the commission, in 2018-19, the backlog of legal cases has significantly reduced, and only cases which were filed after 2017 are currently pending. It said that the NHRC has heard and decided 691 cases and granted compensation worth Rs 25.38 crore.

Dattu credited senior IPS officer Prabhat Singh, Director General (Investigation) of the NHRC who was appointed in January, with bringing down the pendency of cases.



# Zero tolerance towards custodial deaths: Shah

Maintaining that the government has zero tolerance towards custodial deaths, extra-judicial killings and police atrocities, Union Home Minister Amit Shah today emphasised that acts of terror, violence and other human deprivations should also be treated with equal concern in protection of human rights.

Addressing the 26th foundation day celebrations of National Human Rights Commission (NHRC) in Delhi, Shah, in a strong reposte to critics, countered that the Narendra Modi government was working extensively to protect the human rights.

"The government is providing electricity to households, free medical services and gas connections. Providing toilets is also ensuring the human rights of people and the Modi government has done a massive work in the direction to

provide these rights to the people," the minister said.

Shah said, "40,000 civilians have been killed since Independence in Kashmir by militants. Is that not an attack against human rights? I would like to ask, do the families of people who died due to terrorism in Kashmir have no human rights?"

Noting that India's social structure has an inherent strength to protect human rights of poor, weaker sections, women and children, Shah asked the NHRC to broaden the arc of its cognisance to other aspects of the rights. "I believe human rights norms made by the UNHRC are not applicable in India. Their definition of human rights is limited. We should make our own definition."

Invoking Mahatma Gandhi, Shah said his principles and values encompassed a wide range of human rights.

## Human Rights need to be seen in Indian perspective

World standards different from Indian situations

There has not been a bigger violation of human rights than against those who are victims of terrorism and naxalism, Union Home Minister Amit Shah said on Saturday at the 26th National Human Rights Commission (NHRC) foundation day celebration here, amid concerns over human rights issues in Kashmir from several quarters.

He said that human rights in the country need to be looked at with an "Indian perspective". "There is an essential difference in "human rights" as it should be seen in India and in the rest of the world because of the inherent difference in beliefs and circumstances", added the BJP president.

Citing Kashmir as an example, Shah said that more than 40,000 people have been killed because of terrorism in Kashmir since the 1990s. "Don't they have human rights? The NHRC should also look into this," he said. The practice of human rights in the country has been built into the Indian way of life, Shah said. "If we go by global parameters [on measuring human rights violations in India and in the rest of the world], it won't be right. As far as the rights of children and

women are concerned, those of the poor and underprivileged are concerned... they are inbuilt within the society, within our family, without any intrusion from law," Shah said.

While emphasising on zero tolerance towards custodial deaths and police atrocities; he spoke for the protection of human rights of the victims of terrorism and those who have been unable to enjoy the fruits of development because of the violence inflicted by naxalism and terrorism. "I think the time has come to look at human rights from a new dimension," he added.

The BJP leader said thousands of outfits are working on ground to ensure that human rights are enforced there. These too, he argued, should be given space and platform by the NHRC. "The Modi Government has fought successfully against human rights violations. When people don't

have access to toilets, is it not a violation of human rights? When people are forced to burn twigs to cook food, is it not a violation of human rights? By providing 13 crore gas connections, 10 crore toilets, 2.5 crore toilets and 3-3.5 crore houses with electricity, the Modi Government carried out the biggest exercise towards restoring human rights anywhere in the entire world," Shah said.

"Our saints have written literature that explicitly talks about human rights. They gave us the slogan of 'Vasudhaiva Kutumbakam (the world is one family'. So when we were thinking of the entire world, you can see that concerns like human rights were inbuilt in our system," he said.

Shah added that there could not be a better charter of human rights than Narsi Mehta's 'Vaishnava Jana To', sung and immemorialised by Mahatma Gandhi.

## Expand definition of human rights: Amit Shah

There was a need to expand the definition of human rights beyond the international standards as it was not sufficient in the Indian context, Union Home Minister Amit Shah said on Saturday.

Addressing the National Human Rights Commission's 26th foundation day celebration here, Mr. Shah said India would not be as successful in furthering the cause of human rights if it did not go beyond the international standards.

"India and the world have different concepts and situations regarding human rights. If we evaluate it with the world's standards, then perhaps that is not right," he said, adding that the protection of human rights of women and children was "in-built in the social fabric and family system".

Referring to NHRC chairperson Justice (retired) H.L. Dattu, he said: "I request Mr. Dattu to go beyond legal boundaries and give space and a platform to the many people working for human rights protection on their own, as a matter of duty."

He added there was a need to combine the "new concept" of human rights with the traditional.

"I know when I say human rights, people see the meaning as police atrocities and custodial deaths, which is a fact. We have no objections. Every citizen should get the Constitutionally-guaranteed protection. There is no dispute.

# Need to redefine global human rights norms in Indian context, says Shah

New Delhi: Home minister Amit Shah on Saturday said global human rights norms—which tend to focus on police atrocities, custodial deaths and extra-judicial killings—need to be redefined in the Indian context to include denial of a life of dignity due to poverty and rising violence.

Speaking at the 26th Foundation Day celebrations of National Human Rights Commission here, Shah said while police atrocities, unexplained custodial deaths and extra-judicial killings should be avoided at all costs, dealt with sternly and justice ensured, there was a need to spell out "human rights" in the Indian context and widen its scope to include rights of citizens to a life of

The biggest challenges to human rights in our country are poverty and rise in violence. The 5 crore homeless people, 15 crore without access to LPG, 50 crore lacking access to health facilities and 10 crore without toilets were all facing violation of human rights. dignity with access to basic facilities like health, security, toilets, housing, education etc.

Bringing up the example of Jammu & Kashmir, Shah said around 40,000 people have been killed due to terrorist violence since 1990. "Didn't their families have human rights?" he asked. "Due to Naxalism, many districts in the country have been denied development. Many lives have been

lost, many families destroyed... I maintain that there can't be a more serious human rights violation than the sufferings of people hurt by terrorism and Left-wing extremism."

Shah, in his speech delivered in the presence of NHRC chairperson Justice H L Dattu and other members of NHRC, stated: "I believe human rights norms as defined at the international level and in the Indian

context are very different... We must think about expanding the scope of human rights to include many other parameters".

"The biggest challenges to human rights here are poverty and rise in violence. The 5 crore homeless people, 15 crore without access to LPG, 50 crore lacking access to health facilities and 10 crore without toilets four years ago were facing violation of their human rights. The Modi government has tried to fight poverty and assure human rights to around 70 crore people by reaching them these facilities," he stated.

"If NHRC works with the government as well as NGOs and organisations working at the grassroots, this would become the most comprehensive effort across the world to secure human rights," he stated.



### Shah highlights need to redefine human rights

NEW DELHI: Union home minister Amit Shah on Saturday called for the need to redefine human rights in the Indian context, saying that the definition should not be limited to custodial deaths or extra judicial killings.

Speaking on the occasion of the National Human Rights Commission's (NHRC) 26th Foundation Day on Saturday, Shah said, "Global parameters should not be only parameters. It's the time to redefine rights violations with the Indian perspective and should include poverty and violence in our society."

"We have approached the human rights issue with a narrow prism," he added.

The home minister said terrorism or Maoism were the biggest cause of human rights violations, but those killed in such acts and their families did not get as much attention as those killed in police custody. The Centre, he said, had zero-tolerance on custodial deaths and extra judicial killings.

He said more than 40,000 people have been killed in Kashmir since 1990, while Maoism has thwarted the development of several districts. "Was this not a violation of the human rights of these people? But it was never discussed! Modi has solved the problems of these 70 crore people and protected their human rights."

"Indian context is different from rest of the world. We have to redefine human rights according to our challenges and situation," he added, while highlighting that denial of basic facilities such as housing, medical aid, cooking gas and electricity, among others should also fall in the purview of human rights violation.

The minister said protection of human rights of children, women, poor and marginalised sections were inbuilt in the social fabric of the country. "In our family system, the human rights of children and children are protected without any interference of law. In villages, there are many organisations which are helping the poor and the underprivileged as their duty for years."

Underlining the welfare measures of the Narendra Modi-led government, he said five crore families did not have housing facilities, 3.5 crore household were deprived of electricity, 15 crore families did not had access to clean cooking fuel and 50 crore people had no medical insurance cover but the Narendra Modi government has tried to address this issue by taking these facilities to intended beneficiaries after 2014.

#### 'GOVT REDUCED NEED TO FILE RTI PLEAS'

The objective of the Modi government is to proactively put out as much information as possible in public domain to reduce the need for RTI applications, Union home minister Amit Shah said on Saturday. The success of a government does not lie in the high number of Right to Information (RTI) applications, Shah said while addressing the Central Information Commission convention.



## Shah flaunts rights record

New Delhi: Union home minister Amit Shah on Saturday extended the definition of human rights violation to denial of basic facilities such as toilets, electricity, gas connection and shelter and claimed that the Narendra Modi government had done far more by providing these facilities to people than any other government in the past 70 years.

Addressing the foundation day celebration of the National Human Rights Commission (NHRC), Shah said human rights violations should not only mean police atrocities and custody deaths but also denial of basic facilities to people.

"The schemes by the Narendra Modi-led government to provide gas connection, toilets, houses, and electricity to the poor people started in 2014 for the first time since Independence. These schemes were the biggest effort towards restoring human rights in the country," the home minister said.

Shah said people hurt by terrorism and Naxalism were the biggest victims of human rights violations and the definition of human rights in Indian context should be expanded.

On Jammu and Kashmir, he said: "Forty thousand people have been killed in Kashmir due to terrorism since 1992. Do the families of people who were killed have no human rights? Is that not an attack on their human rights?

"I believe that people being affected by terrorism and Maoists attacks are also human rights issue and should be looked at. I think the time has come to look at human rights from a new dimension. We have zero-tolerance against extra-judicial deaths, police atrocities but we should also concentrate equally on terrorism and Naxalism as these are the biggest attack against the human rights."

The NHRC is celebrating its 26th foundation day and Shah was the chief guest.

The mandate of the NHRC
— set up on October 12, 1993 —
is to work for the promotion
and protection of human rights and take cognisance of such
complaints wherein the actions, inaction and omissions
of government functionaries,
prima facie or allegedly, cause
human rights violation.

It is a recommendatory quasi-judicial body, having powers of a civil court to call for any documents and summon any public authority in a case of human rights violation

In a case of human rights violation, its recommendations are twofold: relief to the victim and punishment to the guilty, the NHRC said in a statement


#### SHAH BATS FOR HUMAN RIGHTS



HOME MINISTER Amit Shah on Saturday said that India's human rights policy must focus on the rights of civilians killed by militants or Maoists as much as it does on police atrocities and custodial deaths.


"There is no bigger violation of human rights than those affected by militants in Kashmir or Naxals. We must look at these issues with an Indian outlook," Shah said, while speaking at the 26th foundation day of the National Human Rights Commission (NHRC).

Shah, who was the chief guest at the event, said that western standards of human rights cannot be blindly applied to Indian issues. "Women not having access to toilets and safe methods of cooking is a human rights issue. Modi government has ensured upliftement of millions of individuals from these situations," he said, enumerating the government's efforts at increasing the standard of living.

The Union minister said that under Prime Minister Narendra Modi's leadership, India is moving towards a scenario where there will be no human rights violations.

"India has an inbuilt framework of human rights. Our family values have special protection of women and children, and villages look after the poor believing it to be part of their dharma," he said.
