NHRC notice to UP over mid-day meal of salt and rotis

Lucknow: The National Human Rights Commission on Monday issued a notice to the Uttar Pradesh chief secretary after taking cognizance of an incident where children at a government-run primary school were served salt and rotis served for their mid-day meal, according to a statement. The

commission has sought a detailed report in the matter within four weeks, the statement said. A video of the incident, which took place in Siyur primary school, surfaced on social media on Thursday. Authorities suspended two teachers and served showcause notices to several others.

The NHRC took suo motu cognisance of media reports of a video that went viral showing the "salt rotis" being served in a primary school.

Notice to UP over midday meal menu

Lucknow: The National Human Rights Commission has sent a notice to the Uttar Pradesh chief secretary after taking cognisance of reports that children of a government-run primary school in Mirzapur were served rotis and salt for their midday meal.

According to a NHRC statement, the commission has sought a detailed report about the status of the midday meal scheme across the state within four weeks.

A video of children being served rotis and salt in their midday meal at Siyur Primary School under Jamalpur block of Mirzapur has been widely circulated on social media. The clip purportedly shows a woman distributing rotis and another woman giving salt to children as the midday meal.

Authorities have suspended two teachers.

Observing that the contents of the media reports were "shocking and disgraceful", the panel said that apparently children are not getting nutritious food despite the midday meal scheme. Fri
