 - (ii) Identify voids & gaps in the policy and legal framework, implementation and suggest measures to remove the deficiencies.
 - (iii) Review the present schemes/programmes of the Central and State Government on release and rehabilitation of the bonded labour and suggest improvement therein.
 - (iv) Identify best practice with regard to identification, release and rehabilitation of bonded labour.
- 3. The Core Group will meet at intervals as deemed necessary.
- The participating members of the Core Group stationed outside Delhi shall be entitled for reimbursement of TA for the journeys undertaken by them to attend the meetings of Core Group, as per the norms approved by the Commission.
