 - ii. to review the existing laws and regulations relevant to business, environment and human rights and to assist the Commission on recommending to the concerned Ministries on the effective implementation and/or need for revision of laws and regulations relevant to the issue.
 - iii. to identify barriers in effective access to remedy and to suggest revision of relevant legislations and administrative provisions to ensure that these are accessible to victims of human rights abuse;
 - iv. to examine the best practices in India and abroad dealing with the business, environment and human rights and to make suggestions thereon;
 - v. to advise the Commission on updating the National Voluntary Guidelines on Social, Environment and Economic Responsibilities of Business (NVGs) issued by Ministry of Corporate Affairs in 2011;
 - vi. to undertake national mapping of business, environment and human rights issues and to advise the Commission on recommending to Ministry of Corporate Affairs to address these identified risks in the National Action Plan.
 - 4. The Core Group will meet as and when deemed necessary, in the Commission.
 - 5. The participating Members of the Core Group shall be entitled to an honorarium of Rs. 2000/- and local transportation of Rs. 1000/-. The Members based outside Delhi shall also be entitled for reimbursement of economy class air fare (by Air India) for the to and fro journey undertaken by them to attend the Core Group meetings.
