BRIEF REPORT ON THE WINTER INTERNSHIP PROGRAMME - 2012

(31st December 2012 - 29th January 2013)

In the Winter Internship Programme-2012, total 174 applications were received from Universities/Colleges across the Country out of which 109 applications of 16 States / U.T. were found eligible. Out of these, 109 eligible applications, the Advisory Committee of the Commission for Winter Internship Programme 2012 selected 74 interns (54 on merit & 20 waitlisted).

Out of 74 selected candidates, 48 reported to the internship on 31st December 2012 and 03 interns joined on 1st January 2013. However, 06 interns left the internship due to their personal reasons. In all, 45 interns comprising 21 girls and 24 boys completed their internship. Out of 45 interns, 27 are the Law students, and 18 are the post-graduate students of different discipline of social sciences.

Winter Internship Programme-2012 was inaugurated by Dr. Ashok Sahu, Secretary General, NHRC on 31st December 2012. The programme covered 80 sessions on various human rights related subjects including various activities such as State Presentations, Project work, Project Presentations, Field visits to Tihar Jail and visit to 5 different police stations. Hon'ble Chairperson Shri K. G. Balakrishnan, Justice Shri B. C. Patel, Shri Satyabrata Pal, Dr. Ashok Sahu, Secretary General, and the Senior Officers of NHRC also interacted with Interns on different topics related to Human Rights issues. Interns also presented Cultural Programme on 28th January 2013.

During this Internship interns also got an opportunity to attend three different National conference and national consultation organized by NHRC at I.I.C., New Delhi in small groups.
