- ii. To examine the international agreements/ conventions/ principles relating to environment and climate change signed and ratified by India from the human rights perspective and suggest measures to promote, disseminate and implement such agreements/ conventions/ principles.
- iii. To examine and review the existing legislations and regulations relating to environment and climate change from the human rights perspective and to assist the Commission to make recommendation to the concerned authorities for effective implementation and/or revision/amendment of such legislations and regulations.
- iv. To examine the best practices relating to environment and climate change facilitating better protection and promotion of human rights, in India and abroad and to suggest measures for replication of such practices.

- v. To assist the Commission in identifying issues concerning environment and climate change that have potential to violate human rights and advise the Commission to address identified risks to prevent, mitigate and minimize violation of human rights.
- vi. To advise the Commission on the research studies relating to environment and climate undertaken by Commission.
- vii. To advice the Commission on such other matter relating to environment and climate change as may be referred to it by the Commission from time to time.
- **IV**. The Core Advisory Group will meet as and when deemed necessary by the Chairperson or the concerned Member. The meetings may be held in physical or virtual or hybrid mode.
- V. The participating Members of the Core Advisory Group other than Government officials shall be entitled for an honorarium of Rs. 2000/- and local transportation conveyance of Rs. 1000/- for each meeting. The Members having their residence outsides Delhi shall also be entitled for reimbursement of economy class air fare for to-and-fro journey to be undertaken by them to attend meeting(s) of the Core Advisory Group.
