Age	Not more than 62 years of age		
Remuneration	Rs.36,000/- per month (Rupees Thirty six thousand only) per month.		
Tenure	This contractual appointment is on need based and for a limited period. The initial engagement would be for a period of 3/6 months which can be extended/curtailed subject to satisfactory performance of the individual and requirement of the Commission.		
General conditions	The assignment is on full time basis and the candidates appointed will be required to attend the office on all the working days or on holidays, if required, on account of exigencies of work, for which no additional remuneration/leave will be paid. All rules and regulations with regard to discipline, conduct, punctuality applicable to the regular employees of the Commission shall also be applicable on you during the period of the contractual engagement.		
Selection	The appointment will be made on the recommendations of a Selection Committee constituted for this purpose. The short listed candidates will be called for a personal interview by the Selection Committee.
