Mulakkal trial to begin on Nov 7, nun says shamed on social media

THIRUVANANTHAPURAM: The trial against former Jalandhar Diocese bishop Franco Mulakkal, who is facing sexual assault charges, will begin on November 11. The 44-year-old nun, who has accused him of rape, has sought cancellation of Mulakkal's bail, alleging that he and his followers were threatening witnesses in the case.

Charges against Mulakkal will be read out in the Kottayam district court on the first day of the trial. The charge sheet against him was filed two months ago. The nun separately filed a fresh complaint with the Kerala Women's Commission (KWC) on October 19 alleging that she and other witnesses were being shamed on social media.

Copies of the complaint have also been forwarded to the National Commission for Women and National Human Rights Commission, said Felix Pulludan, a spokesman for the Save Our Sisters (SOS), which was formed in solidarity with the nun.

The nun alleged that a You-Tube channel was releasing videos and audio defaming her. She claimed that some websites had also revealed her identity, flouting the Supreme Court directive.

The sites and the YouTube channel mentioned could not be reached for their comments.

Sister Anupama, one of the five nuns who staged a sit last year seeking Mulakkal's arrest, said, "There is an effort to defame her. All kinds of stories are doing the rounds. They started character assassination after all efforts to intimidate her failed."

She alleged that some of the witnesses were also being intimidated. "He [Mulakkal] is using his power and influence to intimidate witnesses. There are also efforts to delay the trial. But we are sure we will get justice," said Sister Anupama who is staying with the nun at a Kottayam convent.

"The complaint against Mulakkalis serious. You cannot use social media to attack the victim. We have sought a report from the state police chief," said KWC chairperson MC Josephine.

नन ने एनएचआरसी और महिला आयोगों से कानून का उल्लंघन करने वाले लोगों के खिलाफ गंभीर कार्रवाई करने और उसे तथा उसकी साथी ननों को न्याय दिलाने की अपील की। पिछले वर्ष जून में कोट्टायम पुलिस को दी अपनी शिकायत में नन ने आरोप लगाया था कि बिशप मुलक्कल ने मई 2014 में कुराविलांगड में एक अतिथि गृह में उसके साथ बलात्कार किया और बाद में कई मौकों पर उसका यौन उत्पीड़न किया। पुलिस ने इस मामले के सिलसिले में बिशप को गिरफ्तार किया था।

नन ने कहा था कि उन्हें पुलिस के पास इसलिए जाना पड़ा क्योंकि चर्च अधिकारियों ने पादरी के खिलाफ उसकी कई शिकायतों के बाद भी कोई कार्रवाई नहीं की। पुलिस ने इस संबंध में मुलक्कल को गिरफ्तार किया था। मुलक्कल ने इन आरोपों को खारिज करते हुए इन्हें निराधार और मनगढंत बताया था।

Kerala nun approaches women's panels, NHRC against Bishop

The victim in the nun rape case has approached the State Women's Commission and the National women's Commission accusing the rape accused Bishop Franco and his supporters of maligning her through various social media platforms.

The victim nun, in her complaint dated 19 October, has stated that a YouTube Malayalmchannel called Christian Times has been targeting her and the other nuns who supported her in the case, and has been harassing and maligning them.

"After filing the complaint against Bishop Franco, a YouTube channel called Christian Times has been constantly maligning me and my fellow sisters. We suspect that the YouTube chan-

nel is run by Bishop Franco and his fellow workers," the victim wrote in the complaint.

The nun also said that she had filed a complaint against the channel at the Kuravilangad Police Station in Kottayam. However, she said it did not deter the channel from posting more videos.

"After filing the complaint, the channel posted more videos against me and my fellow sisters. In some videos, they used some photos of me, my fellow sisters and officials probing the case. I fear Franco Mulakkal and his group are trying to reveal my identity to the public," she stated. She has also given the video links related to the channel in her complaint.

She has stated that there are already eight cases registered against Bishop Franco for threatening and insult-

ing her and the other nuns in the case.

"It is a clear violation of his bail condition of the Kerala High Court," she said.

She further said that the videos are aimed at threatening and slandering her and her fellow sisters.

False statements, imputations and fabricated stories tarnishing our reputation and character are being systematically spread through the YouTube channel, and we believe Bishop Franco and his group are behind this agenda," she claimed.

The nun pointed out that even after registering a case against the said channel, several videos were being circulated publishing her photograph and revealing her identity. **PTI**
