

## NHRC seeks report from Haryana Chief Secy, police

NEW DELHI, May 15: Taking suo motu cognizance of the attack on a girl hailing from Manipur, the National Human Rights Commission (NHRC) has issued a notice to the Chief Secretary of Haryana and the Commissioner of Police, Gurugram, seeking a detailed report on the incident within four weeks, along with the status of the police investigation.

The NHRC also called for records of registration of the FIR, and sought to know the victim's present health condition and the status of the medical treatment being provided to her.

The suo motu cognizance was taken on the basis of media reports that the 20-year-

old girl from Manipur was subjected to racial discrimination, and brutally attacked by some local people at Faizapur, Gurugram, in Haryana while she was passing through the locality on Sunday afternoon.

## Attack on Manipur girl

NHRC sources said that the girl was saved by some other people. Significantly, police officials who reached the spot, reportedly asked the victim to settle the issue. However, she called the North East Support Centre and Helpline (NESCH), whose members reached the spot at 8.30 pm on that day. It was only then that the vic-

tim's statement was recorded for registration of an FIR.

The NHRC observed that the media reports, if true, point towards a serious issue of violation of human rights of the victim. Instead of initiating the requisite legal process, the police had asked the victim to compromise. The Commission observed that it was disgusting that a woman from the North Eastern part of her own country had been subjected to racial discrimination and physical assault by a local family in the NCR region.

Apparently, the police personnel failed to take necessary action, the NHRC observed, adding that they should have realised the impact of trauma and mental agony the woman was undergoing due to the tragic incident.

The commission would also like to know about the present health condition of the victim and the status of the medical treatment being provided to her by the district authorities, the statement added.

The incident took place at around 6.30pm on last Sunday, May 10.

### पंजाब से उत्तर प्रदेश के महोबा जा रहे थे मजदूर

पंजाब से कुछ प्रवासी मजदूर उत्तर प्रदेश के महोबा जाने के लिए निकले थे। इन मजदूरों के साथ महिलाएं और बच्चे भी थे। बुधवार को जब ये लोग आगरा पहुंचे तो इनके साथ मौजूद करीब आठ साल का बच्चा थककर लटक गया। बच्चे की मां अपने बच्चे की थकावट के चलते अपना सफर नहीं रोकना चाहती थी, इसलिए उसने बच्चे को अपने ट्रॉली बैग पर औंधे मुंह लिटाया और ट्रॉली बैग को खींचने लगी।

#### सपा के बाद कांग्रेस भड़की

इस मामले को लेकर पूर्व मुख्यमंत्री व सपा राष्ट्रीय अध्यक्ष अखिलेश यादव ने ट्वीट किया था। अब कांग्रेस की जिला अध्यक्ष मनोज दीक्षित व कांग्रेस के प्रदेश सचिव अमित सिंह ने कहा कि शासन प्रशासन की संवेदनाएं बिल्कुल मर चुकी है। अफसर सत्ता की चापलूसी में व्यस्त है और मंत्री व सांसद सत्ता की मलाई खाने में व्यस्त है। इस मामले में डीएम प्रभु एन सिंह के खिलाफ कड़ी कार्रवाई होनी चाहिए। कांग्रेस ने डीएम के उस बयान की निंदा की है, जिसमें उन्होंने कहा था कि हम जब छोटे थे और अपने पिताजी के साथ कहीं जाते थे तो हम अटैची पर बैठ जाया करते थे। इस बारे में डीएम प्रभु एन सिंह से बातचीत का प्रयास हुआ पर उनसे बातचीत नहीं हो सकी।
