Jemamani Tahani, a poor woman of Salebhata village in Muribahal block of Balangir district had undergone family planning operation in 2017. She fell sick after a few days of the operation complaining severe abdominal pain. Later on after further checkup, it was found that the doctors of Muribahal CHC had cut her intestine instead of fallopian tube.

Jemamani had lot of health

hazards. Human rights activist Dilip Dash had filed a complaint with the NHRC on the matter and the commission had ordered for compensation.

"But the Health Department played game with the order putting forth spurious arguments. Discarding the plea of health department, the NHRC has stood firm on its order and directed the Chief Secretary on July 22 to comply with the order within six weeks and pay Rs 1 lakh as compensation to Jemamani.

## Aditya death: Crime Branch takes over probe

Director General of Police (DGP) Abhay on Thursday directed the Crime Branch to probe into the death of social worker and motivational speaker Aditya Dash, whose body had been found on the railway tracks near the Temple Road station on July 7.

The case was being investigated by the Government Railway Police (GRP). Following the DGP's directive, a team of Crime Branch officials met the GRP authorities to obtain the necessary information.

Police have also recovered CCTV footage from the Aditya's house and the railway station in course of the investigation.

Aditya's postmortem report revealed that he died because of grievous injuries on the head. But the social activist's relatives and friends have alleged foul play in his death as he was reportedly receiving threat calls for staging an agitation against the liquor mafia.

A hand-written letter in Odia was also found with messages for his family, friends and those associated with the old age home run by him.

The letter was examined by the handwriting bureau of State Forensic Science Laboratory(SFL) here and found to have been written by

Already, his friends, family members and wife have been questioned by the GRP authorities.

The National Human Rights Commission (NHRC) has also sought an Action Taken Report (ATR) from the Commissionerate police over the death of Aditya within four weeks.

### NHRC seeks report on Aditya Das death

The NHRC has sought an Action Taken Report (ATR) from the Commissioner of Police, Bhubaneswar within four weeks on a complaint of 24 July relating to allegations that Aditya Das, a motivational speaker and human rights defender, was murdered and his body retrieved from railway tracks.

Acting on the complaint filed by Supreme Court Lawyer and Social Activist Radhakanta Tripathy the NHRC passed an order with a caution to the Commissioner of Police stating "In case the report is not received within the stipulated period, the Com-

mission shall be constrained to invoke coercive process u/s 13 of the Protection of Human Rights Act, 1993 for personal appearance of the concerned authority".

The petitioner mentioned that that body of Human Rights defender and Social Activist, Aditya Das, was found on the railway track near Lingaraj Temple Road station in the city on July 7 under mysterious circumstances, adding that the police was yet to ascertain the cause

of the death of motivational speaker.

Meanwhile, several new angles regarding the young social activist have come to fore during the preliminary investigation, said Tripathy while referring to the widows statements and that of Aditya's friends.

He also requested to direct the State Authorities and the Lokayukta of the State to ensure the implementation of Whistle-Blowers Protection Act, 2013 in letter and spirit at the earliest.
