#### Another Russian found dead in Odisha, third in fortnight

A citizen of Russia was found dead on a cargo ship anchored at Paradip Port in Odisha on Tuesday. Meanwhile, an investigation is under way into the death of two other nationals of the former Soviet Union nation in the state last month. The latest incident took place a day after the National Human Rights Commission asked the Superintendent of Police of Rayagada in Odisha to send a report on the death of Russian nationals Vladimir Bidenov, 61, and Pavel Antov, 65, at a hotel in the district on December 22 and 24 last.

Milyakov Sergey, 51, was found dead early in the morning at his cabin on the cargo ship, which had anchored at Paradip Port on its way to Mumbai from Chittagong Port in Bangladesh. He was the chief engineer of the ship. Read | Head of major Russian shipyard which built subs for India dies suddenly, same day Putin-critic Antov died in Odisha "This is an unfortunate incident. We received a message from the master of the vessel at 3 a.m. in the morning that the Russian Chief Engineer had died. The shipping agent is doing all the formalities," P L Haranadh, the chairman of Paradip Port Authority, told journalists.

The local police initiated an investigation into the incident. The Crime Investigation Department of the Odisha Police has already been investigating the death of two other Russians at a hotel in Rayagada in the State. Antov, a millionaire, died after falling from the third floor of a hotel on December 25. His friend Bidenov had died in the same hotel on December 22. Antov was also a member of the Legislative Assembly of Vladimir Oblast near Moscow. He had a few months back posted and then quickly withdrew a message criticizing his country's war against Ukraine. Russia's Admiralty Shipyards, which built most of the Indian Navy submarines, also announced the sudden death of its Director General Alexander Buzakov at Saint Petersburg on December 24. Buzakov and Antov were just the latest addition to the long list of Russia's business leaders, who died in the past few months since the former Soviet Union nation launched its war against Ukraine.

# Russian tourists death: NHRC seeks action taken report from Rayagada police

Sources said the CB team on the day recorded official statements of the three ambulance staff who had taken Antov to the district headquarters hospital after he was found in a pool of blood on December 24. The interrogation which took place in Sai International hotel, was aimed at ascertaining the exact sequence of events after Antov was found dead and taken to the hospital.

The officials further questioned the assistant sub-inspector of Rayagada Town police station who was the first to have visited the hotel after Antov's death. Earlier the CB had checked room numbers 319 and 401 of the hotel where the duo stayed, and seized their laptops, mobile phones and other items for investigation besides interrogating others.

Meanwhile, following demands of Berhampur-based social activist Rabindra Mishra, the NHRC sought an ATR from the superintendent of police, Rayagada within four weeks on the two deaths.

आयोग ने ये भी पाया कि प्रथम 'ष्टया, यह लोक सेवकों की ओर से एक आपराधिक लापरवाही प्रतीत होती है। इसको लेकर आयोग ने झारखंड के मुख्य सचिव, पुलिस महानिदेशक समेत केंद्रीय स्वास्थ्य और परिवार कल्याण मंत्रालय को भी नोटिस जारी कर मामले में छह सप्ताह के भीतर रिपोर्ट मांगी है। मुख्य सचिव को नकली दूध बेचने की व्यापकता पर एक विस्तृत रिपोर्ट प्रस्तृत करने के लिए कहा गया है।

डीजीपी से विशेष रूप से एफआईआर दर्ज करने के बारे में पूछा गया है, जिसमें लगाए गए दंडात्मक अपराधों, जांच की प्रगति और आरोपी व्यक्तियों के विवरण, यदि कोई हो, का उल्लेख होना चाहिए। आयोग ने कहा कि रिपोर्ट में पुलिस द्वारा शुरू की गई निवारक कार्रवाइयों का भी उल्लेख होना चाहिए। वहीं स्वास्थ्य सेवा के महानिदेशक को झारखंड राज्य में नकली दूध और अन्य खाद्य पदार्थों की बिक्री को खत्म करने के लिए की गई या प्रस्तावित निवारक कार्रवाई के संबंध में एक रिपोर्ट प्रस्तुत करने कहा गया है।

आयोग ने यह भी पाया कि खाद्य अपिमश्रण निवारण अधिनियम लागू होने के बावजूद, ऐसा प्रतीत होता है कि इसे झारखंड में प्रभावी ढंग से लागू नहीं किया जा रहा है। गौरतलब है कि मीडिया रिपोर्ट के मुताबिक, धनबाद में 3 लाख लीटर दूध की डिमांड है, जबिक प्रोडक्शन 1.90 लाख लीटर ही है। यही वजह है कि नकली दूध का बड़ा बाजार है।

दिल्ली के रोहिणी के सेक्टर-31 में खुले सीवर में गिरे पिता-पुत्र मामले में राष्ट्रीय मानवाधिकार आयोग (NHRC) ने स्वतः संज्ञान लिया है। आयोग ने दिल्ली के मुख्य सचिव और पुलिस आयुक्त को नोटिस जारी कर इस मामले में विस्तृत रिपोर्ट मांगी है। बता दें कि दो दिन पहले सीवर पिता-पुत्र गिर गए थे, पिता को तो बाहर निकाल लिया गया और लापता आठ साल के बेटे की अभी तलाश जारी है।

कथित तौर पर घटना तब हुई जब सीवर का ढक्कन गायब था, जिसे शायद नशा करने वालों ने चुरा लिया था। आयोग ने नोटिस जारी कर रिपोर्ट में, जिसमें बचाव अभियान की वर्तमान स्थिति, पुलिस द्वारा जांच की स्थिति, बचाए गए पिता का चिकित्सा उपचार और पीड़ित परिवार को दिया गया मुआवजा के बारे में जानकारी मांगी है।

आयोग घटना के लिए जिम्मेदार दोषी अधिकारियों के खिलाफ हुई कार्रवाई के बारे में भी जानकारी मांगी है। आयोग ने पाया है कि पुलिस और स्थानीय नागरिक अधिकारियों को यह जांचने के लिए अतिरिक्त सावधान और सतर्क रहने की आवश्यकता है कि असामाजिक तत्व क्षेत्र में मैनहोल के ढक्कन और ग्रिल चोरी न करें। इसलिए आयोग ने दोनों प्राधिकरणों से इस मुद्दे के समाधान के लिए उठाए गए या उठाए जाने वाले कदमों के बारे में जानकारी मांगी है।

आयोग ने बताया कि 29 मार्च, 2022 को रोहिणी के सेक्टर-16 में इसी तरह की घटना में सीवर लाइन में गिरने से चार लोगों की मौत हो गई थी। इसमें भी घटना का स्वत: संज्ञान लिया था और अधिकारियों से रिपोर्ट मांगी थी।

एनएचआरसी ने एक बयान में कहा कि कथित तौर पर यह घटना इसलिए हुई क्योंकि सीवर का ढक्कन गायब था, संभवतः नशे के आदी लोगों ने इसे चुरा लिया था। एनएचआरसी ने दो दिन पहले दिल्ली में रोहिणी के सेक्टर-31 में एक पिता और पुत्र के खुले सीवर में गिरने की मीडिया की खबरों का स्वतः संज्ञान लिया।

अधिकार पैनल ने कहा कि जहां पिता को बाहर निकाला गया और अस्पताल में भर्ती कराया गया, वहीं लापता आठ वर्षीय बच्चे की तलाश अग्निशमन दल कर रहा थी। बयान में कहा गया है कि आयोग ने दिल्ली के मुख्य सचिव और पुलिस आयुक्त को नोटिस जारी कर रिपोर्ट मांगी है।

#### NHRC seeks report over spurious milk

The National Human Rights Commission (NHRC) Monday issued a statement stating that it has taken suo motu cognizance of a vernacular media report claiming that refined and caustic soda is being mixed in one litre of milk to make it 15 litres of spurious liquid to reap profits in Dhanbad. According to reports, there is a demand for nearly 3 lakh litres of milk in Dhanbad, while production is only 1.90 lakh litres. This is the reason that there is a big market for spurious milk. It is also reported that 1kg of skimmed milk after mixing refined oil and caustic soda, becomes 15 kg of milk and this spurious milk cannot be detected even by a lactometer. Milk sellers are also allegedly being mixed with urea, detergent and starch to make spurious milk to earn profits at the cost of the health of the people. The commission in its statement said it has observed that the contents of the media report, if true, amounts to violation of rights related to the health of the people and prima facie, it appears to be a culpable negligence on the part of the public servants. "The commission has further observed that despite the Prevention of Food Adulteration Act in force, it appears that it is not being implemented effectively in Jharkhand. The Act provides enormous power for inspecting any place where the food item is manufactured, stored for sale or even where the food items have been kept for making it adulterated. The power has also been given to seize such adulterated food items and to take all legal actions against the seller or manufacturer of food items," it said. Accordingly, it has issued notices to the chief secretary, director general of police and the director general, health services, Union ministry of health & family welfare calling for the reports within six weeks in the matter.

While the chief secretary has been asked to submit a detailed report on the prevalence of spurious milk selling; the DGP has been specifically asked about the registration of FIRs by mentioning the penal offences invoked, progress of investigation and the details of the accused persons, if any. The report must also mention the preventive actions initiated by the police. It can be noted here that there is a possibility of infection in the stomach leading to cancer when one consumes such spurious milk. The testing of refined and caustic soda is done in the lab. It can be tested at home also. Despite repeated attempts, Dhanbad DC Sandeep Singh could not be reached over phone for his comments or whether he has received report from NHRC or state so far.

दो रूसी नागरिकों - पावेल एंटोव और व्लादिमीर ब्यदानोव की रहस्यमय मौतों पर एक ताजा घटनाक्रम में, अपराध शाखा (सीबी) ने सोमवार को इस संबंध में एक पुलिस अधिकारी और तीन एम्बुलेंस कर्मचारियों से पूछताछ की। राष्ट्रीय मानवाधिकार आयोग (एनएचआरसी) ने भी रायगड़ा पुलिस से उस दिन की कार्रवाई रिपोर्ट (एटीआर) मांगी थी।

सूत्रों ने कहा कि सीबी टीम ने उस दिन तीन एम्बुलेंस कर्मचारियों के आधिकारिक बयान दर्ज किए, जो 24 दिसंबर को खून से लथपथ पाए जाने के बाद एंटोव को जिला मुख्यालय अस्पताल ले गए थे। साईं इंटरनेशनल होटल में हुई पूछताछ का उद्देश्य था एंटोव को मृत पाए जाने और अस्पताल ले जाने के बाद की घटनाओं के सटीक क्रम का पता लगाने के लिए। अधिकारियों ने रायगढ़ टाउन पुलिस स्टेशन के सहायक उप-निरीक्षक से भी पूछताछ की, जो अंतोव की मौत के बाद सबसे पहले होटल आए थे। इससे पहले सीबी ने होटल के कमरा नंबर 319 और 401 की जांच की थी, जहां दोनों ठहरे थे और अन्य लोगों से पूछताछ के अलावा उनके लेपटॉप, मोबाइल फोन और अन्य सामान जांच के लिए जब्त कर लिया था। इस बीच, बेरहामपुर के सामाजिक कार्यकर्ता रवींद्र मिश्रा की मांगों के बाद, एनएचआरसी ने रायगड़ा के पुलिस अधीक्षक से दो मौतों पर चार सप्ताह के भीतर एटीआर मांगी।

## NHRC team to visit Didi's turf

# Violence Against Christian Adivasis In Chhattisgarh: Mob Vandalises Churches, Attacks Police

The attacks against Christian Adivasis in Chhattisgarh took an ugly turn yesterday as a mob allegedly comprised of Hindu right-wing groups vandalised a church in Narayanpur and attacked the police severely injuring Superintendent of Police (SP) Sadanand Kumar who along with his team went there to pacify the people who were protesting against alleged conversion by Christian missionaries.

While Kumar got a head injury, at least five other police personnel had minor injuries and were released after preliminary treatment, reports PTI.

The incident took place around afternoon when a mob gathered near Viswadeepti school to protest against a clash that broke out at Ekda village between two communities over the alleged religious conversion by the Christian missionaries. Inspector General of Police (IG) Sundarraj P told PTI, "Around 2,000 people were present for a meeting held in Narayanpur. Local tribal leaders Rupsai Salam, Narayan Markam and few others were leading the gathering".

He also added that after the meeting the crowd got divided in two parts and armed with sticks and stones, they entered the church within the school premises and vandalised it. Upon receiving information as the police reached there to disperse the mob, they were also attacked.

SP Kumar while talking to the reporters from Hospital where he was being treated for head injuries told, "I rushed to the spot with other officials and tried to pacify the protestors. They seemed convinced and were about to return, but suddenly someone hit me with a stick on my head."

Referring to a meeting that the administration had with the protestors, before the demonstration, Narayanpur collector Ajeet Vasant said that the community leaders assured them of peaceful protest but it turned violent. However, the locals have accused the police of inaction and said that it was due to them that the Hindu right wing group could garner such strength.

While talking to Outlook, Suman Mandvi (name changed on request) says, "The attacks on us went on undeterred despite several police complaints. On Saturday, they attacked our brothers in Gorrah village. As the gathering in the church lost their temper, they also attacked a few of them. This news of clash spread quickly and on Sunday, the right-wings gathered people from nearby districts and came on 150 bikes with sticks and other weapons. They then brutally attacked our people across villages."

After the attack, hundreds of Christian Adivasi fled to Jungle and contacted the police but in vain. Then, they tried to connect to National Human Rights Commission (NHRC) upon whose intervention the police took up the matter and tried to pacify the crowd. However, Mandvi adds, "On Sunday evening they blocked the road and police did nothing at all. On Monday, the situation culminated to the attacks on churches."

Another social activist Vijay Kumar (name changed on request) told Outlook, "They not only vandalised the church in the school, the mob got scattered and then demolished another three churches in the villages namely Kodagaon, Bandapal and Amasara."

Some videos received by Outlook, not yet verified, show people barging into churches and destroying properties with sticks. Had police earlier taken action, the situation wouldn't have been like this, adds Mandvi, who has been supporting the homeless people with the basic rations and other resources. At least 1000 people had left their home out of fear and are now living in different parts of the district.

Chandan Kashyap, the Congress MLA of Narayanpur while talking to Outlook said, "We have seen the videos of clashes and this is very unfortunate. I am currently in Assembly as it is on session and I have already informed the CM yesterday evening about the happenings."

On being asked, whom he thinks is behind all these, he denied naming any organization but said, "Look, still now we don't know who are doing this. But we have told SP and Collector to properly investigate the issue and book the offenders. I will go back to Naryanpur and will talk to the local leaders soon. But there must be some outsiders who are provoking the people."

Notably, Rupsai Salam, who is named by the IG is the Narayanpur district president of BJP who, the locals allege, were involved in the eviction and forceful gharwapsi of

Christian Adivasis for quite a long time. The earlier spate of attacks on the Christian Adivasis on December 18, against which they gathered in front of Narayanpur district collectorate and submitted application to register an FIR also named Ruspsai Salam along with several other Hindu right-wing members.

The fact-finding committee comprising of Mr. Irfan Engineer, Director, Centre for Study of Society and Secularism, Mumbai, Mr. Ashok Verma, Ranchi-based senior journalist, Nicholas Barla, CBCI, New Delhi and Mr. Brijendra Tiwari, Convenor, All India People's Forum Chhattisgarh that independently went to investigate the ongoing violence in their reports also talked about the police inaction. In their reports they note, "The early warning of the campaign to forcibly convert Christians manifested in the month of October however the District Administration ignored the early warning such as the threats and intimidations targeting Christian Adivasis. These intimidations were reported but no action was taken which tantamounted to breach of peace in the locality."

They also referred to incidents where 21 Adivasi families had been taken to village temple and had been forcibly converted to Hinduism through sprinkling of water and some other rituals. As per the reports, the right-wingers also took away their Bibles and made them chant Hindu sermons. Dhantaraj Tandon of Sarva Anusuchit Jati Samaj told the team that "RSS's campaigns should be held responsible for attacks on Christian Adivasis", the report added.

Currently, there is huge police deployment and apparently the situation is under control. However, one of the locals told Outlook, "Hum jaye to jaye kahan. Har jagah se hum mar e kha rahe hai... (We can't go anywhere. Everybody from every direction is targeting us).
