आइएसएफ ने आरोप लगाया था कि राज्य पुलिस ने इस घटना में कोई कार्रवाई नहीं की। आइएसएफ के सिर्फ एक प्रत्याशी नौशाद सिद्दीकी ने भांगड़ विधानसभा क्षेत्र से जीत दर्ज की थी। आरोप है कि इसके बाद तृणमूल समर्थकों ने आइएसएफ कार्यकर्ताओं को परेशान करना शुरू कर दिया था। चुनाव बाद हिंसा की जांच कलकत्ता हाई कोर्ट के पांच जजों की पीठ के निर्देश पर सीबीआइ कर रही है।

As per the report, 10% of them are pregnant but unaware of their lawful rights and the benefits ensured under various government schemes. They are not granted any maternity leaves and child care facilities and no healthy diet is provided to them by the departments concerned.

The NGRC has observed that the contents of the news report, if true, raise serious issues of human rights violations. It is the prime duty of the State Government to safeguard the lawful rights of vulnerable sections of society, including poor labourers and women workers who are giv-

आईएसएफ नेमानवाधिकार आयोग मेंकी थी शिकायत आरोप था कि आईएसएफ कर्मियों की पिटाई की गयी थी. उस आरोप के मद्देनजर ही राष्ट्रीय मानवाधिकार आयोग नेराज्य के पुलिस महानिदेश को तलब किया है. इंडियन सेक्युलर फ्रंट (आईएसएफ) नेआरोप लगाया था कि राज्य पुलिस नेइस घटना मेंकोई कार्रवाई नहीं की थी. उन्होंनेमानवाधिकार आयोग का दरवाजा खटखटाया था. सूत्रों नेकहा हैकि उसी शिकायत के आलोक मेंराज्य के पुलिस महानिदेशक को दिल्ली तलब किया गया है.

आईएसएफ नेलगाया अपनेकार्यकर्ताओं को प्रताड़ित करनेका आरोप सूत्रों के मुताबिक, आईएसएफ नेशिकायत की हैिक चुनाव परिणाम की घोषणा के बाद सेउसके कार्यकर्ताओं को प्रताड़ित किया जा रहा है. आईएसएफ उम्मीदवार नौशाद सिद्दीकी के भांगड़ विधानसभा क्षेत्र सेजीतनेके बाद तृणमूल कार्यकर्ताओं नेआईएसएफ कार्यकर्ताओं को परेशान करना शुरू कर दिया था. मानवाधिकार आयोग में आरोप लगाया गया हैिक उनका सिर फोड़ दिया गया था.

विधानसभा चुनाव के नतीजेदो मई को घोषित हुए थे. तृणमूल प्रचंड बहुमत सेजीती थी और ममता बनर्जी राज्य मेंलगातार तीसरी बार सता मेंआयीं. इस बीच आरोप लगाया गया कि नतीजों की घोषणा के दिन सेही विपक्ष का उत्पीड़न शुरू हो गया था. ऐसेभी आरोप लगेकि देगंगा मेंएक खेत मेंबम विस्फोट मेंएक आईएसएफ कर्मी मारा गया था. भांगड़ मेंअलग-अलग जगहों पर आईएसएफ कार्यकर्ताओं पर हमलेके आरोप भी लगेथे. झूठे केस में कई आइएसएफ के कार्यकर्ताओं की पिटाई के भी आरोप लगेहैं.

They are not granted any maternity leaves and child care facilities and no healthy diet is provided to them by the departments concerned," NHRC stated in the press statement.

The Commission has observed that the contents of the news report, if true, raise serious issues of human rights violations of the helpless poor women labourers.

It is the prime duty of the State to safeguard the lawful rights of the vulnerable sections of society including poor labourers and women workers who are giving birth during work without any special care, though guaranteed under the law, the release stated.

Accordingly, NHRC has issued a notice to the Chief Secretary Government of Maharashtra calling for a detailed report within four weeks, the statement said.

The matter pertains to the media report, carried out on January 11. In the media report, the Taluka Medical Officer of the Srigonda has claimed that they have a record of about 35 women labourers, who delivered babies in the current crop season.

मुंबई: राष्ट्रीय मानवाधिकार आयोग (एनएचआरसी) ने अहमदनगर जिले की श्रीगोंडा तहसील में कई कारखानों के लिए गन्ना काटने में लगी महिला मजदूरों की दुर्दशा के बारे में एक मीडिया रिपोर्ट का स्वत: संज्ञान लिया है. रिपोर्ट के अनुसार, उनमें से 10% गर्भवती हैं लेकिन अपने वैध अधिकारों और विभिन्न सरकारी योजनाओं के तहत सुनिश्चित लाभों से अनजान हैं। उन्हें कोई मातृत्व अवकाश और बाल देखभाल सुविधाएं नहीं दी जाती हैं और संबंधित विभागों द्वारा उन्हें कोई स्वस्थ आहार प्रदान नहीं किया जाता है।

एनजीआरसी ने देखा है कि समाचार रिपोर्ट की सामग्री, यदि सही है, तो मानवाधिकारों के उल्लंघन के गंभीर मुद्दे उठाती है। राज्य सरकार का यह प्रमुख कर्तव्य है कि वह बिना किसी विशेष देखभाल के काम के दौरान जन्म देने वाले गरीब मजदूरों और महिला श्रमिकों सहित समाज के कमजोर वर्गों के कानूनी अधिकारों की रक्षा करे। तदनुसार, आयोग ने महाराष्ट्र सरकार के मुख्य सचिव को नोटिस जारी कर चार सप्ताह के भीतर विस्तृत रिपोर्ट मांगी है। इस साल 11 जनवरी को जारी मीडिया रिपोर्ट के अनुसार, श्रीगोंडा के तालुका चिकित्सा अधिकारी ने कहा है कि उनके पास लगभग 35 महिला मजदूरों का रिकॉर्ड है, जिन्होंने मौजूदा फसल के मौसम में प्रसव कराया है। उन्होंने अपनी तहसील के अंतर्गत आने वाले सात प्राथमिक स्वास्थ्य केन्द्रों का डाटा दिया है और यह भी कहा है कि कारखानों और बागवानों के प्रबंधन के लिए यह आवश्यक है कि मजदूरों को स्वस्थ आहार के अधिकार, कुछ दिनों की छुट्टी और आवश्यक स्वास्थ्य और स्वास्थ्य के बारे में जागरूक किया जाए। गर्भावस्था के दौरान और प्रसव के बाद चिकित्सा

NHRC seeks report on pregnant woman's arrest, death in Odisha's Rayagada

)The National Human Rights Commission (NHRC) has taken cognizance of a petition and sought an Action Taken Report (ATR) from the Rayagada district collector on the arrest and death of a pregnant woman who was staging a sit-in demonstration in front of a company demanding employment. ATR was also sought on the arrest of other pregnant women and villagers, who were also agitating on the same demand The NHRC in its January 16 order stated it received a complaint from human rights activist Radhakanta Tripathy about the death of one woman Mala Nayak of Andirakanch Village, in Odisha's Rayagada district on January 11. It was alleged that the deceased along with 12 other women were arrested on December 26 for staging a dharna in front of Utkal Alumina demanding employment in the company." The deceased and four other women were pregnant at the time of their arrest. Though their bail plea was accepted by the court on January 6, she, along with others couldn't be released as another case was registered by police against them. The victim was in her advanced stage of pregnancy but norms related to arrest and judicial custody of pregnant women were not adhered to by the authorities, the complaint said. The complainant also highlighted several other issues concerning the lack of basic amenities in the area/district leading to serious violations of the human rights of inhabitants of the area concerned. Seeking ATR from the Rayagada district Collector, the NHRC forwarded the petition to the Odisha Chief Secretary for information. Tripathy pointed out that the then Prime Minister, Rajiv Gandhi was a catalyst for launching the Orissa Tribal Development Project for Kashipur in 1987 After more than a decade and hundreds of crores having been spent, there is no perceptible improvement in the people's plight. The pauperisation is visible when one hits the dirt tracks to go around the faceless villages of the region, the complaint alleged. In the present case, the arrest of poor, tribal pregnant women and keeping them behind bars without medical treatment and adequate legal aid pose serious questions of human rights, it was alleged. There is severe environment pollution and lack of livelihood support in the affected area, the petitioner contended. Tripathy requested the NHRC to investigate the case in detail by deputing a team of officials or through the Special Rapporteur, direct the DGP, Chief Secretary, Ministry of Health and Family Welfare and also Ministry of Rural Development, Govt of India and the District Collector and Superintendent of Police, Rayagada to act over the issue immediately. The inquiry report must be submitted with legal action against the errant officials. The family members of the victim Pregnant women must be highly compensated, the petitioner said. The NHRC has also been requested to ensure livelihood support to the villagers, health care on a war footing, and basic amenities to the poor villagers along with benefits under social welfare.
