Advocate Henri Tiphagne, national convener of AiNNi, has given a call to NGOs not to attend the NGO meeting called by NHRC on September 5 as this meeting is only a symbolic one meant to show NGO relation before the G-20 meeting delegates and to gain membership to the Global Alliance of National Human Rights Institutions (GANHRI) which has been deferred for a year in March 2023 due to it not being in compliance with the UN Paris Principles.

बयान में कहा गया है कि रिपोर्ट में पुलिस द्वारा दर्ज की गई प्राथमिकी और मृतक के परिजनों को अगर कोई मुआवजा दिया गया है तो उसका जिक्र होना चाहिए।
