New Delhi, Jan 29 (UNI) The National Human Rights Commission (NHRC) on Monday sought a report from the Telangana government regarding a video where female police officials were seen dragging a protesting student by her hair in the Ranga Reddy district. In a notice issued to the Chief Secretary and the Director General of Police in Telangana, the NHRC requested a detailed report within four weeks. The report should include information on the actions taken and the health status of the victim girl, it said. The NHRC has taken suo motu cognizance of a media report on a video clip showing lady police officials dragging a protesting student by her hair in the Ranga Reddy district of the state during an agitation by some students of Professor Jayanshankar Telangana State Agricultural University (PJTSAU) on January 24. The video of the reported incident has gone viral on social media. The commission has observed that if the contents of the media report are true, they raise serious issues of the violation of human rights of the victim girl, as mentioned in a statement, the NHRC said. According to the media report, published on January 25, the students were protesting against a decision of the State Government to allocate 100 acres of land belonging to the university for the construction of the new High Court complex.

Hyderabad, Jan 29 (IANS): A lady police constable who dragged a girl student by hair during a protest in Hyderabad last week has been suspended.

Cyberabad Police Commissioner Avinash Mohanty on Monday ordered suspension of the constable serving at Rajendranagar police station.

The action came on a day when National Human Rights Commission (NHRC) has issued a notice to Telangana government. The Commission sought a detailed report on the incident within four weeks.

The state government has also been asked to inform about the action taken against the police officials involved.

The NHRC took suo moto cognizance of a media report on a video clip showing lady police officials dragging a protesting student by her hair in the Ranga Reddy district during an agitation by some students of the Professor Jayashankar Telangana State Agricultural University (PJTSAU) on January 24.

The video of two policewomen on a scooty chasing a female protestor and the one riding pillion pulling her by her hair went viral.

The girl, an activist of ABVP, fell down.

The incident occurred during a protest by ABVP against the allotment of university land for construction of the High Court. Cyberabad Police had ordered an inquiry into the incident.

New Delhi [India], January 29 (ANI): The National Human Rights Commission (NHRC) sent notice to the Telangana government over media reports of lady police officials dragging a girl student by her hair in the Ranga Reddy district on Monday. The NHRC sought a detailed report within four weeks, including action taken against the responsible police officials. It has taken suo motu cognizance of a media report on a video clip showing lady police officials dragging a protesting student by her hair during an agitation on January 24.

Notably, the protest was staged by some of the students of Professor Jayanshankar Telangana State Agricultural University (PJTSAU). The Commission observed that the contents of the media report, if true, raised the serious issue of a violation of the human rights of the victim girl. Accordingly, it issued notices to the Chief Secretary and the Director General of Police, Telangana. The report sought should include the action taken and the health status of the victim girl.

According to the media report carried on January 25, the students were protesting against a decision by the state government allocating 100 acres of land belonging to the university for the construction of the new High Court complex.

The video of the reported incident went viral on social media. Meanwhile, the video triggered public outrage and as the police action drew heavy criticism from the opposition, Rajendranagar police issued a clarification stating that the action by two lady constables was unintentional and they wanted to grab the woman protestor's hand. Opposition leaders, including Bharat Rashtra Samithi (BRS) MLC Kalvakuntla Kavitha, raised serious concerns over police brutality and demanded stern action. (ANI)

New Delhi, Jan 29 (PTI) The NHRC has sent a notice to the Telangana government and the state's police chief over media reports that some policewomen allegedly dragged a female student by her hair during an agitation by some students in Ranga Reddy district, officials said on Monday.

The National Human Rights Commission (NHRC), in a statement, observed that the content of the media report, if true, raises a serious issue of violation of human rights of the student.

The NHRC has sought a detailed report, including details of action taken against the police officials responsible for the alleged incident, within four weeks, the rights panel said in a statement.

The NHRC has taken suo motu cognisance of a report on a video clip purportedly showing policewomen "dragging a protesting student by her hair in Ranga Reddy district of Telangana during an agitation by some students of the Professor Jayashankar Telangana State Agricultural University (PJTSAU) on 24th January, 2024," it said.

The video has since gone viral on social media, the NHRC said.

Accordingly, it has issued notices to the chief secretary and the director general of police of Telangana, seeking a detailed report on the incident within four weeks. It should also include the action taken report and health status of the girl, it added.

According to the report, carried on January 25, the students were protesting against a decision of the state government allocating 100 acres of land belonging to the university, for the construction of the new High Court complex, the statement said.



NHRC issues notice to Telangana govt. after policewoman drags girl student by hair

The incident happened on January 24, during an agitation by some students of the Professor Jayanshankar Telangana State Agricultural University (PJTSAU), against the State government's decision to allocate 100 acres of land belonging to the university, for constructing a new High Court complex.

The commission observed that the incident raised concerns of violation of human rights of the victim. Accordingly, it has issued notices to the Chief Secretary and the Director General of Police, Telangana, calling for a detailed report in the matter within four weeks. It should also include the action taken report and health status of the victim girl, the NHRC said.

Accordingly, it has issued notices to the Telangana chief secretary and the director general of police, calling for a detailed report on the matter within four weeks. It should also include the action-taken report and health status of the victim, said the NHRC.

According to reports, the students were protesting against a decision of the Telangana government to allocate 100 acres of land belonging to the university for the construction of a new high court complex.

Constable suspended

Rajendranagar Police Station's Inspector B Nagendra Babu told South First, "The constable sitting pillion on the two-wheeler and seen pulling the hair of the student is Ayesha. She has been placed under suspension."

He added, "The constable has been working for three years in the same police station and will continue to be under suspension until the investigation is completed."

The victim has been identified as the ABVP's Telangana secretary Ch Jhansi. A first-year LLM student of PJTSAU, she had been on strike along with others for 16 days against a government order (GO 55) to construct a new building for the high court on the varsity's agri-biodiversity land.

Her friends told South First that she had sustained scratches as she fell on the road and was given first aid and glucose.

विशेष रूप से, विरोध प्रदर्शन प्रोफेसर जयनशंकर तेलंगाना राज्य कृषि विश्वविद्यालय के कुछ छात्रों द्वारा किया गया था। (पीजेटीएसएयू)। आयोग ने पाया कि मीडिया रिपोर्ट की सामग्री, यदि सच है, तो पीड़ित लड़की के मानवाधिकारों के उल्लंघन का गंभीर मुद्दा उठाया गया है। तदनुसार, इसने मुख्य सचिव और पुलिस महानिदेशक, तेलंगाना को नोटिस जारी किया। मांगी गई रिपोर्ट में की गई कार्रवाई और पीड़ित लड़की की स्वास्थ्य स्थिति शामिल होनी चाहिए।

25 जनवरी को आई मीडिया रिपोर्ट के अनुसार, छात्र नए उच्च न्यायालय परिसर के निर्माण के लिए विश्वविद्यालय की 100 एकड़ भूमि आवंटित करने के राज्य सरकार के फैसले का विरोध कर रहे थे। कथित घटना का वीडियो सोशल मीडिया पर वायरल हो गया। इस बीच, वीडियो ने सार्वजनिक आक्रोश पैदा कर दिया और पुलिस की कार्रवाई की विपक्ष द्वारा भारी आलोचना की गई, राजेंद्रनगर पुलिस ने एक स्पष्टीकरण जारी किया जिसमें कहा गया कि दो महिला कांस्टेबलों द्वारा की गई कार्रवाई अनजाने में थी और वे महिला प्रदर्शनकारी का हाथ पकड़ना चाहते थे। भारत राष्ट्र समिति (बीआरएस) एमएलसी कल्वकुंतला कविता सहित विपक्षी नेताओं ने पुलिस की बर्बरता पर गंभीर चिंता जताई और कडी कार्रवाई की मांग की।

Jammu & Kashmir: NHRC Takes Steps to Fill Human Rights Gap Through Inaugural Open Public Hearing

The National Human Rights Commission (NHRC) is taking a proactive approach to address the human rights void in Jammu and Kashmir. The NHRC has announced its intention to conduct a maiden, open public hearing on rights violations in the region, particularly after the revocation of its special status in 2019 and the abolition of the local rights watchdog.

According to an NHRC notice, the commission will hold a "Camp Sitting and Open Public Hearing on grievances of the general public regarding alleged human rights violations in the UT of Jammu and Kashmir from February 7 to February 9 in Srinagar."

This announcement follows a Supreme Court directive less than a year ago, urging the central government to consider establishing a mechanism allowing residents of Jammu and Kashmir to file complaints directly with the NHRC from within the region.

The NHRC notice invites people to register their complaints by January 29, specifically related to "alleged violation of human rights by a public servant or negligence by a public servant in prevention of such violation." Complaints deemed suitable for inquiry will be addressed during the open public hearing.

Jammu and Kashmir has faced a void in the realm of human rights watchdogs since the closure of the State Human Rights Commission (SHRC) by the central government in 2019. The SHRC, among other institutions, was dismantled following the abrogation of the special status. Several human rights organizations ceased to operate due to the government's intolerance for dissent.

Notably, rights activist Khurram Parvez, recognized by the UN's human rights body as a "tireless advocate for the families of disappeared," has been in detention since 2021.

The government-appointed SHRC was actively investigating numerous cases of rights violations, primarily involving security forces. In March 2020, the NHRC was granted authority to address all human rights concerns in the Union Territory. However, the absence of local offices has hindered its effectiveness.

The closure of the SHRC prompted criticism from the UN rights body in September 2020, with nine rapporteurs urging the government to explain the shutdown. The UN body also called for an investigation into alleged instances of forced disappearance and mass graves in Jammu and Kashmir. The abrupt closure of the SHRC left families with

limited options, and the letter highlighted its role in acknowledging crimes previously denied by the government.

The SHRC had acknowledged the 1991 Kunan Poshpora incident and the Sailan Poonch massacre, where security forces allegedly shot 19 people at point-blank range in August 1998. The NHRC's upcoming open public hearing aims to address the longstanding human rights concerns in Jammu and Kashmir.
