

Man dies in city excise dept custody, probe ordered

Ranchi: Tension brewed in the Gonda locality in city after a person accused of selling liquor illegally was picked up by the local excise department personnel on Saturday and died during their custody on the same day. The department, however, refuted claims of torture leading to the death of Nitesh Vishwakarma and said the victim tried to kill himself by suicide following which he was rushed to the hospital but did not survive. Meanwhile, the Ranchi district administration has ordered a judicial inquiry into the incident on Sunday and sought the chief judicial magistrate's support in appointing a judge to conduct the probe.

After Nitesh's death, Gonda police registered a case against the excise department officials under Section 302 of the IPC based on a complaint lodged by a victim's relative on Sunday.

Police, however, said the complainant has neither mentioned the names nor the number of accused personnel even after accusing the department officials of beating up Nitesh, leading to his death.

Earlier, the department said it apprehended Nitesh on Saturday in connection with the illegal sale of liquor and brought him to its office under the Gonda police station. In its custody room, Nitesh attempted to end his life by suicide after which the personnel rushed him to the hospital but died, the department added.

On Sunday, the district administration also formed a medical board, which conducted the post-mortem on Nitesh's body under the supervision of a magistrate. The whole process was also video-graphed. Later, the district administration will submit a report of the incident to the National Human Rights Commission.

The Supreme Court of India on Monday rapped the Gujarat government for granting remission to the 11 convicts in the Bilkis Bano gangrape case. The 11 convicts, sentenced to life imprisonment, were released by the Gujarat government in 2022 under its remission policy.

The Supreme Court bench said that the Gujarat government did not have the jurisdiction to take a decision onb the remission of sentence for the 11 convicts, who were imprisoned for gang raping Bilkis Bano and murdering members of her family.

Further, the apex court has ruled that the released convicts in the case have two weeks to surrender before the authorities.

Bilkis Bano case: Timeline of events

During 2002 Gujarat riots, Bilkis Bano, who was five months pregnant at the time, fled her home in Randhikpur village with her 3-year-old daughter, husband and other family members.

Bano and her family had reached the Chhaparvad district when a mob of 20-30 men attacked their group with sickles, swords and stones. 11 of these men gang-raped Bilkis Bano, her mother and three other women. Seven of her family members, including her 3-year-old daughter, were killed by the mob.

After the local police rejected her case, Bilkis Bano turned to the National Human Rights Commission (NHRC) in 2003, eventually filing an appeal in the Supreme Court.

The Supreme Court instructed CBI to take up the investigation of the case. The investigation agency apprehended all the accused in 2004. The trial was transferred from Ahmedabad to Mumbai over fears of evidence tampering.

13 individuals in the case were convicted on charges of rape, murder and conspiracy, out of which 11 were given life sentences. These convicts then challenged their conviction in the Bombay High Court in 2008.

After several attempts the overturn the judgement and CBI pushing for the death penalty, the High Court upheld its previous order of life sentences for 11 convicts in 2017.

One of the convicts, Radheshyam Shah, approached the High Court and Supreme Court seeking early release in 2022, having already served 15 years, reported Outlook India. The SC passed this case to the Gujarat government.

On August 15, 2022, the Gujarat government released all 11 convicts in the gangrape case under its remission policy. However, this decision sparked a major public backlash, and prompted petitions from opposition MPs.

Bilkis Bano in 2022 filed an appeal in the Supreme Court to review the decision of the Gujarat government ordering release of the 11 gangrape convicts.

The matter was listed in the Supreme Court in March 2023, after which arguments from Centre and Gujarat government were heard. SC also asked the state government to present the original documents on the basis of which the decision was taken.

On January 8, 2024, the Supreme Court decided to dismiss the remission of the convicts in Bilkis Bano gang rape case, ordering them to surrender to the authorities in two weeks.

Kolkata, Jan 8 (IANS): Leading human rights group, Association for Protection of Democratic Right (APDR) has forwarded a communique to the National Human Rights Commission (NHRC) accusing West Bengal government of discriminating against the Teesta River flash flood victims.

APDR General Secretary, Ranjit Sur, said that the affected victims of Garfur Busty, Teesta Bazar, numbering eight families were not compensated with the amount of Rs 75,000 which the Chief Minister Mamata Banerjee had disbursed at an administrative programme on December 8 last year.

"There are complaints about some non-genuine beneficiaries availing the compensation and hence there was clear discrimination in award of the compensation, where collusion of panchayat officials with the alleged fake victims became apparent," Sur said.

In the communique to the NHRC, the APDR has also said that in absence of a proper rehabilitation programme many victims are still forced to stay in deplorable conditions at makeshift shelters in a community hall of Teesta Bazar.

"Moreover, the victims happened to belong to an economically weaker section as most of them were daily wagers that were dependent on river based economic activities like quarrying on Teesta River Bank.

"Closure of quarries by district administration affected their livelihood and they are staring at starvation and malnutrition issues in near future," said the APDR communique to NHRC.

The association has also requested the commission to depute an inspection team and address the grievances of affected victims more comprehensively including speedy compensation, rehabilitation and restoration of their livelihood through resumption of quarry at Teesta River bank.

BHUBANESWAR: The National Human Rights Commission (NHRC) has issued a show cause notice to the state government as to why compensation of Rs 1 lakh should not be paid to a tribal youth, whose family planning surgery was conducted without his consent.

Acting on a petition, the apex human rights panel has asked the chief secretary to respond to the notice within six weeks. On August 3, last year, staff of Mathili subdivisional hospital in Malkangiri district had allegedly conducted vasectomy on a differently-abled tribal unmarried youth without taking his consent. He was among five persons from Ambaguda and nearby villages who underwent the procedure that day.

The matter came to fore after a group of social activists brought it to the notice of the CDMO alleging the local health staff did so to meet their target of family planning operations. The youth was taken to the hospital on the pretext of regular health check up and given Rs 2,000 incentive post surgery

Stating the family planning surgery was conducted in violation of the government guideline and protocol, petitioner Radhakanta Tripathy said human rights of the youth were infringed due to the negligence on part of the surgeon and the ASHA worker, who took him to the hospital.

Pursuant to the directions of the NHRC, special secretary of Health and Family Welfare department had stated the incentive of Rs 2,000 was not paid to the beneficiary but the ASHA worker as the victim did not have a bank account. The surgeon also admitted his negligence and suggested the recanalisation of the no-scalpel vasectomy (NSV) needed to be done after obtaining consent from the client.

Superintendent of Mathili SDH will ensure provision of travel, procedure related requirements and necessary coordination support for the same. After considering the reports, the NHRC observed the case to be a fit case for award of compensation.

The NHRC has taken "suo motu cognisance of a media report that an engineering girl student committed suicide by jumping from the fifth floor of her college in Rangareddy district, Telangana on January 5," it said.

The Commission has observed that the content of the news report, if true, raises a "serious issue of violation of human rights" which is a matter of concern.

Accordingly, it has issued notices to the chief secretary and the director general of police in the government of Telangana, seeking a detailed report within four weeks, the statement said.

"The report should also include the outcome of the police investigation and inquiry conducted by the college administration, the action taken against the persons found responsible for the incident, and steps taken or proposed to be taken to ensure that such painful incidents do not recur," it said. According to the media report, carried on January 6, the eyewitnesses said the victim took the extreme step even as her fellow students screamed at her to stop. She was rushed to a private hospital in Isnapur by the students and college management, where the doctors pronounced her "brought dead", it added.

Hyderabad: The National Human Rights Commission (NHRC) has taken suo motu cognisance of a media reports that an engineering girl student committed suicide by jumping from the fifth floor of her college in Telangana on Friday, January 5.

The incident took place at Gitam University in Rudraram.

The Commission has observed that the contents of the news report, if true, raise a serious issue of violation of human rights, which is a matter of concern. Accordingly, it has issued notices to the chief secretary and the director general of police, seeking a detailed report in the matter within four weeks.

The report should also include the outcome of the police investigation and inquiry conducted by the college administration, the action taken against the persons found responsible for the incident, and steps taken or proposed to be taken to ensure that such painful incidents do not recur, NHRC said.

According to the media report, the eyewitnesses said that the victim took the extreme step even as her fellow students screamed at her to stop. She was rushed to a private hospital in Isnapur by the students and college management, where the doctors pronounced her "brought dead".

The 18-year-old student belonged to the West Godavari district in Andhra Pradesh.



Bilkis Bano: गर्भवती बिलकिस से दुष्कर्म, उनके परिवार की हत्या करने वालों को किस कानून के तहत मिली थी रिहाई?

Bilkis Bano Case: दोषियों की रिहाई के बाद बिलिकस बानो और उनके परिवार ने इस मामले को कोर्ट में चुनौती दी थी। जहां, बिलिकस ने अपनी और परिवार की सुरक्षा की भी मांग गुजरात सरकार से की थी। वहीं, रिहा होने के बाद दोषियों का फूलमाला पहनाकर और मिठाई खिलाकर स्वागत किया गया था।

गुजरात के गोधरा में उम्र कैद की सजा काट रहे 11 दोषियों को 15 अगस्त 2022 को रिहा कर दिया गया था। ये सभी बिलिकस बानो से सामूहिक दुष्कर्म और उनके परिवार के सात लोगों की हत्या के मामले में सजा काट रहे थे। दोषियों की रिहाई के बाद बिलिकस बानो और उनके परिवार ने इस फैसले पर निराशा जताई और मामले पर सुप्रीम कोर्ट का दरवाजा खटखटाया। इस केस में अब आठ जनवरी को फैसला आया है। सर्वोच्च न्यायालय ने गुजरात सरकार के फैसले को पलटते हुए सभी दोषियों की सजा में मिली छूट को रद्द कर दिया।

बिलकिस बानो कौन हैं, 2002 में उनके साथ क्या हुआ था?

27 फरवरी 2002 को साबरमती एक्सप्रेस में गोधरा स्टेशन के पास आग लगा दी गई। इस घटना में अयोध्या से लौट रहे 59 श्रद्धालुओं की मौत हो गई। घटना के चलते गुजरात में दंगे भड़क उठे। दंगों की आग तीन मार्च 2002 को बिलिकस के परिवार तक पहुंच गई। उस वक्त 21 साल की बिलिकस के परिवार में बिलिकस और उनकी साढ़े तीन साल की बेटी के साथ 15 अन्य सदस्य भी थे। चार्जशीट के मुताबिक बिलिकस के परिवार पर हिसया, तलवार और अन्य हिथयारों से लैस 20-30 लोगों ने हमला बोल दिया था। इनमें दोषी करार दिए गए 11 लोग भी शामिल थे।

दंगाइयों ने बिलिकस, उनकी मां और परिवार की तीन अन्य महिलाओं के साथ दुष्कर्म किया। उन सभी को बेरहमी से पीटा। हमले में परिवार के 17 में से सात सदस्यों की मौत हो गई। छह लापता हो गए। केवल तीन लोगों की जान बच सकी। इनमें बिलिकस, उनके परिवार का एक पुरुष और एक तीन साल का बच्चा शामिल था। इस घटना के वक्त बिलिकस पांच महीने की गर्भवती थीं। दंगाइयों की हैवानियत के बाद बिलिकस करीब तीन घंटे तक बेसुध रहीं।

घटना के बाद क्या हुआ?

घटना के बाद बिलिक्स लिमखेड़ा पुलिस स्टेशन पहुंचीं। जहां उन्होंने शिकायत दर्ज कराई। सीबीआई के मुताबिक शिकायत दर्ज करने वाले हेड कॉन्स्टेबल सोमाभाई गोरी ने भौतिक तथ्यों को दबाया और बिलिक्स की शिकायत को तोड़-मरोड़ कर लिखा। यहां तक की उन्हें मेडिकल जांच के लिए सरकारी अस्पताल में तब

ले जाया गया जब वो गोधरा के राहत कैंप में पहुंची। राष्ट्रीय मानवाधिकार आयोग और सुप्रीम कोर्ट के दखल के बाद बिलकिस का मामला सीबीआई को जांच के लिए स्थानांतरित कर दिया गया।

सीबीआई की जांच से सजा तक क्या-क्या हुआ?

सीबीआई ने मामले की नए सिरे जांच शुरू की। जांच में सामने आया कि मारे गए लोगों का पोस्टमॉर्टम तक ठीक से नहीं किया गया था। सीबीआई जांचकर्ताओं ने हमले में मारे गए लोगों के शव निकाले और पाया कि शवों में से किसी में भी खोपड़ी तक नहीं थी। सीबीआई के मुताबिक पोस्टमार्टम के बाद लाशों के सिर काट दिए गए थे, ताकि शवों की शिनाख्त न हो सके।

मामले का ट्रायल शुरू हुआ तो बिलिकस बानों को जान से मारने की धमकी मिलने लगी। इसके बाद ट्रायल को गुजरात के बाहर महाराष्ट्र शिफ्ट कर दिया गया। मुंबई की कोर्ट में छह पुलिस अधिकारियों और एक डॉक्टर समेत कुल 19 लोगों के खिलाफ आरोप दायर हुए। जनवरी 2008 में एक विशेष अदालत ने 11 आरोपियों को दुष्कर्म, हत्या, गैर कानूनी रूप से इकट्ठा होने समेत अन्य धाराओं में दोषी ठहराया गया। वहीं, बिलिकस की रिपोर्ट लिखने वाले हेड कॉन्स्टेबल को कोर्ट ने आरोपियों को बचाने के लिए गलत रिपोर्ट लिखने का दोषी पाया गया। जबिक, सात अन्य आरोपियों को सबूतों के अभाव में बरी कर दिया गया। वहीं, एक आरोपी की ट्रायल के दौरान मौत हो गई।

जिन 11 आरोपियों को दोषी ठहराया गया था उनमें जसवंतभाई नाई, गोविंदभाई नाई, नरेश कुमार मोरिधया (मृतक), शैलेष भट्ट, राधेश्याम शाह, बिपिन चंद्र जोशी, केसरभाई वोहानिया, प्रदीप वोहानिया, बाकाभाई वोहानिया, राजूभाई सोनी, नितेश भट्ट, रमेश चंदना और हेड कांस्टेबल सोमाभाई गोरी शामिल थे। जसवंत, गोविंद और नरेश को बिलिकस से दुष्कर्म किया था। वहीं, शैलेष ने बिलिकस की बेटी सालेहा को जमीन पर पटक कर मार डाला था।

मई 2017 में बॉम्बे हाईकोर्ट ने सामूहिक दुष्कर्म मामले में 11 लोगों की आजीवन कैद की सजा को बरकरार रखा। वहीं, पुलिसवालों और डॉक्टर समेत बाकी सात लोगों को बरी कर दिया। अप्रैल 2019 में सुप्रीम कोर्ट ने गुजरात सरकार को आदेश दिया कि वो बिलकिस को दो हफ्ते के अंदर 50 लाख रुपये मुआवजे के तौर पर दे।

रेप और हत्या के दोषियों को आखिर किस आधार पर छोड़ा गया है?

11 दोषियों में से एक राधेश्याम शाह ने सुप्रीम कोर्ट में सजा माफी के लिए याचिका दायर की। कोर्ट ने गुजरात सरकार को याचिका पर फैसला लेने को कहा। इसके बाद गुजरात सरकार ने एक कमेटी गठित की थी। इस कमेटी ने माफी की याचिका मंजूर कर ली। इसके बाद इन लोगों की रिहाई हुई।

किस कानून के तहत हुई दोषियों की रिहाई?

संविधान के अनुच्छेद 72 और 161 में राष्ट्रपति और राज्यपाल के पास कोर्ट से सजा पाए दोषियों की सजा को कम करने, माफ करने और निलंबित करने की शक्ति है। कैदी राज्य का विषय होते हैं इस वजह से राज्य

सरकारों के पास भी दंड प्रक्रिया संहिता (सीआरपीसी) की धारा 432 के तहत सजा माफ करने का अधिकार है।

हालांकि, सीआरपीसी की धारा 433A में राज्य सरकार पर कुछ पाबंदियां भी लगाई गई हैं। जैसे फांसी या उम्रकैद की सजा पाए दोषी को तब तक जेल से रिहा नहीं किया जा सकता है जब तक उसने कम से कम चौदह साल की कैद की सजा नहीं काट ली हो। सजा माफी की याचिका लगाने वाले राधेश्याम को जेल में 15 साल चार महीने हो चुके थे।

बिलिक्स ने क्या विकल्प अपनाया?

बिलिकस ने सरकार के इस आदेश को सुप्रीम कोर्ट में चुनौती दी। सरकार के इस आदेश को किसी भी अन्य सरकारी आदेश की तरह ही चुनौती दी जा सकती है। इस पर सुनवाई करते हुए सुप्रीम कोर्ट ने सभी 11 दोषियों की सजा पर मिली छूट को रद्द कर दिया।

मुंबई के कई हिस्सों में प्लेसमेंट कार्यालय खोलने और नौकरी चाहने वालों को धोखा देने के आरोप में दो लोगों को गिरफ्तार किया गया है। अपराध शाखा के एक अधिकारी ने सोमवार को यह जानकारी दी। उन्होंने कहा कि उन्होंने 100 से अधिक लोगों को धोखा दिया है और विभिन्न बैंक खातों और नकदी संग्रह के माध्यम से अब तक 1 करोड़ रुपये के लेनदेन का पता लगाया गया है।

Bilkis Bano Case: सुप्रीम कोर्ट ने 2002 में गोधरा कांड के बाद हुए दंगों के दौरान बिलकिस बानों के साथ गैंगरेप और उसके परिवार के सदस्यों की हत्या के मामले में 11 दोषियों को रिहा करने के गुजरात सरकार के सजा माफी के आदेश को 8 जनवरी को रद्द कर दिया. जस्टिस बी.वी. नागरता और उज्ज्वल भुइयां की पीठ ने अपने फैसले में कहा, "हमारा मानना है कि गुजरात सरकार के पास छूट के लिए आवेदन पर विचार करने या उत्तरदाताओं (दोषियों) को छूट देने का कोई अधिकार नहीं था."

कौन हैं जस्टिस बीवी नागरता?

जस्टिस बीवी नागरता का जन्म 30 अक्टूबर, 1962 को कर्नाटक के पन्दवापुरा में हुआ था. नागरता ने जीसस एंड मैरी कॉलेज से स्नातक किया और इसके बाद दिल्ली के लॉ कॉलेज से कानून की डिग्री ली. उन्होंने अपने करियर की शुरुआत बेंगलुरु में एक वकील के रूप में की थी.

क्विट हिंदी में 2 जनवरी 2023 छपी एक रिपोर्ट्स के मुताबिक, साल 1975 में नागरता ने बी एन गोपाला कृष्णा से शादी की थी. उनसे उन्हें दो बेटियां नयनतारा बीजी और प्रेरणा बीजी हैं.

फरवरी 2008 में जस्टिस नागरता कर्नाटक हाईकोर्ट में एक अतिरिक्त न्यायाधीश के रूप में नियुक्त की गई थीं. फिर 2010 में उन्हें स्थायी न्यायाधीश बनाया गया. 2021 में जब सुप्रीम कोर्ट की कॉलेजियम ने केंद्र सरकार के पास कोर्ट में खाली पड़ी वैकेंसी के लिए 9 नामों की सिफारिश की तो उनमें जस्टिस बीवी नागरता का नाम भी शामिल था. इस तरह बीवी नागरता सुप्रीम कोर्ट की जस्टिस बनीं.

जस्टिस नागरता के पिता ईएस वेंकटरमैया 1989 में करीब छह महीने के लिए भारत के मुख्य न्यायामूर्ति (CJI) थे.

जस्टिस नागरत्ना ने अपने करियर में कई अहम फैसले दिए हैं, जिसमें 2016 में केंद्र सरकार द्वारा लागू किये गये नोटबंदी के आदेश को गलत ठहराना, 2012 में केंद्र को ब्रॉडकास्ट मीडिया को रेगुलेट करने के निर्देश और 2019 में मंदिर व्यावसायिक प्रतिष्ठान नहीं हैं, उसके कर्मचारी ग्रेच्युटी के हकदार नहीं हैं, का फैसला शामिल है.

कौन हैं जस्टिस उज्ज्वल भुइयां?

जस्टिस उज्ज्वल भुइयां का जन्म २ अगस्त 1964 को गुवाहाटी में हुआ था.

उन्होंने अपनी स्कूली शिक्षा डॉन बॉस्को हाई स्कूल, गुवाहाटी से की और कॉटन कॉलेज, गुवाहाटी से पढ़ाई की.

भुइयां ने गुवाहाटी के सरकारी लॉ कॉलेज से कानून में स्नातक की डिग्री और गौहाटी विश्वविद्यालय से कानून में मास्टर की डिग्री प्राप्त की.

20 मार्च 1991 को, उन्हें असम, नागालैंड, मेघालय, मणिपुर, त्रिपुरा, मिजोरम और अरुणाचल प्रदेश की बार काउंसिल में नामांकित किया गया था.

6 सितंबर 2010 को, उन्हें गुवाहाटी हाईकोर्ट द्वारा सीनियर एडवोक्ट के रूप में नामित किया गया था.

21 जुलाई 2011 को तात्कालीक राज्य सरकार ने उन्हें गुवाहाटी हाईकोर्ट में अतिरिक्त महाधिवक्ता (AAG) के रूप में नियुक्त किया था.

उन्हें 17 अक्टूबर 2011 को गुवाहाटी हाईकोर्ट के अतिरिक्त न्यायाधीश के रूप में पदोन्नत किया गया था और 20 मार्च 2013 को स्थायी न्यायाधीश बनाया गया था.

भुइयां को 3 अक्टूबर 2019 को बॉम्बे हाईकोर्ट और फिर 22 अक्टूबर 2021 को तेलंगाना हाईकोर्ट के न्यायाधीश के रूप में ट्रांसफर किया गया था.

28 जून 2022 को उन्हें तेलंगाना हाईकोर्ट के मुख्य न्यायाधीश के रूप में पदोन्नत किया गया था

14 जुलाई 2023 को उन्हें सुप्रीम कोर्ट में न्यायाधीश के रूप में नियुक्त किया गया था.

वकील शोभा गुप्ता कौन हैं?

शोभा गुप्ता को कानूनी पेशे में केवल सात साल ही हुए थे, जब राष्ट्रीय मानवाधिकार आयोग (NHRC) ने उन्हें 2002 के गुजरात दंगों के दौरान गैंगरेप की शिकार पीड़िता बिलकिस बानो का वकील नियुक्त किया था.

लिंक्डइन पर शोभा गुप्ता की प्रोफाइल के अनुसार, उन्हें वकालत का अब तक करीब 3 दशक का अनुभव है. उन्होंने 1990 में राजस्थान हाईकोर्ट में अपने लॉ करियर की शुरुआत की थी. इसक बाद से अब तक वो कई सरकारी पैनल और प्राइवेट फर्म की अधिवक्ता रह चुकी हैं. साल 2000 में वो एनएचआरसी से जुड़ी हैं. इसके बाद उन्होंने दिल्ली हाईकोर्ट और सुप्रीम कोर्ट में भी वकालत की है. वो कई बड़े मामलों में अधिवक्ता के तौर पर सुप्रीम कोर्ट और हाईकोर्ट में बहस कर चुकी हैं.

India court overrules early release of 11 men in Bilkis Bano gang rape case

India's Supreme Court has quashed the remission given to 11 Hindu men who had been jailed for life for the gang rape of Bilkis Bano and murdering her relatives during anti-Muslim riots in the western state of Gujarat in 2002. The top court on Monday directed the 11 men to surrender to the prison authorities in Gujarat within two weeks. "Their plea for protection of their liberty is rejected," the court said. "To keep them out would not be in consonance of the rule of law.

"Bano, now in her 40s, was five months pregnant when she was gang-raped during the violence, which saw nearly 2,000 people, most of them Muslims, killed in some of the worst religious riots India has experienced. Seven of the 14 people murdered in one incident were Bano's relatives, including her three-year-old daughter, whose head was smashed on the ground by the perpetrators in Gujarat's Dahod district.

Prime Minister Narendra Modi was Gujarat's chief minister at the time, and his Hindu nationalist Bharatiya Janata Party (BJP) still rules the state. The 2002 riots have long hounded Modi, who was accused of ordering the state authorities to allow the bloodshed which went on for weeks. Modi has repeatedly denied having any role in the violence and the Supreme Court has said it found no evidence to prosecute him.

'Our wounds are still fresh'

The 11 men, convicted in early 2008, were ordered freed by the Gujarat government in August 2022 after the prison they were being held in recommended their release, considering the time they had served and their good behaviour. A viral video at that time showed the relatives and supporters of the men welcoming them with sweets and garlands.

But their release also drew widespread condemnation, especially since it coincided with India's Independence Day celebrations, when Modi spoke about women's safety and security.Bano's uncle and a witness in her case, Abdul Razzak Mansuri, told Al Jazeera the top court's ruling was a step towards justice for her. "We are glad that the court directed the accused to be sent back to jail in two weeks.

The Gujarat government released them [convicts] and it was very hurtful for us as it was against all the logic," he said. "We will never forget the memories [of 2002 riots]. Our wounds are still fresh." Kaleem Siddiqui, a minority rights activist in Gujarat's main city of

Ahmedabad, alleged the 11 men were released by the BJP government to score political mileage before the state elections.

"The Gujarat government was working with a mindset that they have to free the men somehow," he told Al Jazeera. "In the future, the Gujrat government should not try to protect them. The accused should get the punishment that has been awarded to them." The opposition Congress party welcomed Monday's ruling, saying it exposed the BJP's "callous disregard for women".

"It is a slap on the face of those who facilitated the illegal release of these criminals and also those who garlanded the convicts and fed sweets to them," spokesman Pawan Khera posted on X, previously known as Twitter. "India will not allow administration of justice to be incumbent on the religion or the caste of the victim or the perpetrator of a crime." There was no immediate reaction to the verdict from the 11 men and the Gujarat government.

In its verdict, the top court held that Gujarat did not have the authority to reduce the sentence of the 11 men, adding that "arguments with emotional appeal become hollow when placed in juxtaposition with the facts of the case".

"It is a significant judgment which upheld the rule of law as the central pillar on which Indian democracy rests," Vrinda Grover, one of the lawyers who argued on behalf of Bano in the top court, told Al Jazeera. "The court has said that the rule of law will apply to all the people, regardless of who they are."

I really appreciate that we have a wonderful relationship with India," she told news agency ANI.

The Bangladeshi prime minister further stressed the historical significance of India's assistance during the Bangladesh Liberation War in the year 1971 and the challenges the country faced subsequently in 1975. She praised the long-standing partnership between the two nations and emphasised India's significance as a vital ally. UN expresses concern over 'mass arrests' during Bangladesh polls

Meanwhile, the United Nations rights chief on Monday condemned the violence that occurred during Bangladesh polls boycotted by the opposition, calling for the nation to strengthen democracy.

"I implore the government to take the necessary steps to ensure that the human rights of all Bangladeshis are fully taken into account, and to strengthen the underpinnings of a truly inclusive democracy," Volker Turk said in a statement. The United Nations High Commissioner for Human Rights pointed out that "thousands of opposition supporters have been detained arbitrarily or subjected to intimidation".

"Such tactics are not conducive to a truly genuine process," he warned."Around 25,000 opposition supporters have been arrested, including key party leaders, since October 28," the statement said, adding that at least 10 of them had reportedly died or been killed in custody. How to recognise rage farming and keep yourself safe from it

Perhaps you were peacefully scrolling through Instagram or X (formerly Twitter) and laughing at some funny videos when it suddenly caught your eye: a comment or post claiming that women do not deserve human rights, that a religious minority should leave the country, or that your favourite actor looks like an insect.

Though content of this kind can range from mildly irritating to openly genocidal, they fall under a media category known as "rage bait," with their posters knowingly engaging in an act that has come to be called "rage farming." As social media platforms such as X promote programmes which let verified users turn their impressions into cash through ad revenue sharing,

Many have found that the best way to capture eyes is by posting offensive, violent, or controversial matter in order to start internet fights that draw in as many participants as possible. In this way, troll accounts with followers in the single or double digits can publish posts that are soon viewed tens of thousands of times, encouraging ad placements in their replies.

On Instagram, Meta promotes posts from its text-based social media app Threads. However, some users have complained that they are being shown provocative content from Threads posters they never chose to view or follow.Rage bait and rage farming can also be seen on Facebook, TikTok, Reddit, and YouTube. Some examples of this include staged videos of break-ups or harassment, sensational stories that never took place, morphed pictures being passed off as real news, bigoted memes, or even just cruel comments under your own posts.

When you interact with such content, you only add more fuel to the fire, even if your intentions are pure. A rage farming account may encourage you to waste your time and mental energy on it, provoking you to share its content with your own followers so that they can also join in to support you.

Other rage farming accounts may try to scam you, expose your address, send you suspicious links, or send their own followers to harass you until you are forced to leave the platform. Some even hope to seek real life fame by carrying out digital mischief, with you inadvertently promoting them.

Here are 10 ways to protect yourself and your social media from rage farmers/rage bait Avoid opening or reading the comments under other people's social media posts, and especially when the post is viral or deals with sensitive issues. Avoid interacting with social media users who do not put their own photo or name in their profiles.

Generic handles like "@Batman393001" are a strong sign of troll accounts looking to trigger outrage.Do not debate Holocaust deniers, Nazis, flat Earthers, climate change sceptics, homophobes, transphobes, religious bigots, casteists, rape apologists, known misogynists, racists, etc. who challenge facts or human rights standards to drive engagement.

Firmly ignore aggressive social media users who have fewer followers than you, as this is a tactic for many rage farming accounts to capture the attention of your (larger and more valuable) digital audience. Consider limiting who all can reply to your posts, especially if you want your account to remain a conflict-free space.

Choose social media feeds which show you only the accounts you are following, rather than the algorithmic feed with viral or promoted posts mixed in as well. In case your posts attract rage farmers, choose to hide their replies or delete them where possible. Reporting comments, downvoting content, and blocking users is strongly recommended, so that your algorithm will show you more appropriate material in the future.

In case you need to share a rage farmer's post or comment, do not re-post their content directly, but instead upload your own screenshot and conceal their name in order to cut off their engagement.

Maintain and enforce a strict "no forwards" policy on group chats created for formal and professional purposes, such as the building's housing association or workplace departments. In case you are targeted by threats and violent media, capture screenshots of the post and the original account bio, to file a police complaint.

Take steps to renew commitment to democracy, human rights: UN rights chief to Bangladesh govt

UN Human Rights Chief Volker Türk on Monday (8 January) called on Bangladesh's newly elected government to take steps to renew the country's commitment to democracy and human rights.

He also voiced distress that the "environment for Sunday's poll was marred by violence and repression of opposition candidates and supporters", according to a press statement published on the website of the Office of the United Nations High Commissioner for Human Rights (OHCHR).

Türk said, "In the months leading up to the vote, thousands of opposition supporters have been detained arbitrarily or subjected to intimidation. Such tactics are not conducive to a truly genuine process." I implore the Government to take the necessary steps to ensure that the human rights of all Bangladeshis are fully taken into account, and to strengthen the underpinnings of a truly inclusive democracy in the country."

The OHCHR statement stated that, "Mass arrests, threats, enforced disappearances, blackmailing and surveillance were all methods reportedly used by law enforcement officials prior to the ballot, which was boycotted by the main opposition Bangladesh Nationalist Party.

"Acts of political violence, including arson attacks allegedly committed by opposition groups, have also been reported." Around 25,000 opposition supporters have been arrested, including key party leaders, since 28 October. At least 10 opposition supporters reportedly died – or were killed – in custody in the last two months, raising serious concerns about possible torture or harsh conditions of detention, the UN Human Rights chief said.

"Many human rights defenders have been forced to go into hiding, and some have fled the country, while dozens of suspected enforced disappearance cases have been reported, mostly in November," reads the OHCHR statement. Türk said, "These incidents must be independently investigated, and those responsible must be brought to justice in fair and transparent trials.

"Violations and irregularities during the campaign and on election day itself should also be thoroughly and effectively investigated."Türk said, "Democracy was hard won in Bangladesh and must not become cosmetic. Bangladesh has been a role model of development, and I fervently hope this will translate into the political and institutional spheres too. The future of all Bangladeshis is at stake.

106 kidnapped children rescued last year by Nalasopara anti-human trafficking cell, most are girls

MUMBAI: The Nalasopara unit of the Anti Human Trafficking Cell (AHTC) of the Mira Bhayander Vasai Virar (MBVV) Commissionerate last year rescued 106 children who were reported missing. They have been reunited with their parents.

Police said that 104 cases of minors kidnapped were solved with the rescue of 106 children, including 71 girls. Cases of kidnapping under POCSO sections were registered in police stations. Police relied on technical investigations and informer networks to trace the children. A number of the missing children were from other districts and states.

In 2022, the Nalasopata AHTC solved 106 cases involving the kidnapping of minors and 112 children were rescued. Since the formation of the commissionerate in October 2020, a total of 298 kidnapped children have been rescued from Mira-Bhayander and Vasai-Virar. The Nalasopara region tops with the maximum number of cases of minors going missing and kidnapping cases being registered.

'They are victims of systematic human trafficking'

One of the many investigators questioning the 66 people who were on the flight on their way to Nicaragua and who were sent back to India from France shares interesting insights with Prasanna D Zore/Rediff.com after questioning the people who were travelling, how they planned to pay anywhere between Rs 60 lakh (Rs 6 million) and Rs 80 lakh (Rs 8 million), and whether or not, and under what circumstances, will FIRs be filed against these travellers.

This official from the Gujarat police requested to speak without his identity being disclosed for this interview because of the sensitivity and involvement of foreign embassies in this investigation which with the help of the CBI -- the central nodal agency in such cases -- spans across Dubai, France and probably countries like Nicaragua, Mexico and the USA.

What are the various possibilities the Gujarat police is investigating in this case where people from Gujarat and Punjab were deported from France on December 26? We are looking for the possible network of agents -- a mixed bag that would include locals as well as global agents -- who were behind all these passengers travelling to the USA (via Nicaragua, a Central American country).

If somebody is going from here (India) to Dubai and from Dubai to Nicaragua and from Nicaragua to the USA, the process requires agents I guess at every node in this journey. What made these people take such a huge risk in their effort to reach the US illegally? Traditionally, people from Punjab and Gujarat have been going to the USA and Canada illegally. These people must have been fascinated by life there (in Western countries like the US and Canada), which must not be true, but yes, they're fascinated by life there.

Any insights you received while questioning these people from Gujarat as well as the agents you must have arrested or maybe questioned?In Gujarat, it's largely a tradition in some districts to go to the USA and Canada; same is in Punjab also.Illegally?Yes, both the ways -- if legally possible, then legally, but if not legally possible, they will find out alternate avenues.Did you get a chance to figure out the modus operandi of these agents as well people who were trying to move to the US? Was this -- the India-Dubai-Nicaragua-Mexico-US channel -- used for the first time?

Not for the first time obviously. Earlier also some flights and a few people went to the Mexico border. As of now we are focused on this particular case in which the plane has been returned from France for immediate investigation.

However, any lead or any agent in between who could eventually pop on our radar, we will go into all those aspects too. Have you arrested any travel agents from Gujarat yet? We haven't registered an FIR yet; we are doing primary inquiry only as of now. Yes, we have travelled a lot, in the sense that our investigation has progressed quite well; probably we'll go for filing an FIR also in time to come.

Will FIRs be also filed against these people who were travelling illegally? As of now we are treating them as victims of a systematic (human trafficking) racket as of now.Let us see how they are cooperating with the police and what evidence they bring to the table. Their statements and their cooperation will yield us (help us arrest) some agents and expose the whole network.We have both the alternatives (to treat these people as victims or file an FIR against them).

We'll see how we can take any lawful action against these people after discussion with our PPs (public prosecutors). How did they get these visas? Did they get a visa to Nicaragua from India or from Dubai? Visas are issued against the passport. It is immaterial from where you are travelling. If you own a USA passport and you travel from Singapore or Bangkok or Mumbai the visa is issued against that passport that you are a USA citizen. Same about that thing (the visas issued to these Indian travellers).

Till Dubai all of them had a visa with them; from Dubai to Nicaragua for Indian passengers, for Indian passport-holders, visa is issued in Nicaragua on arrival. They were supposed to get a visa at Nicaragua after landing. Is that the reason why these agents choose Nicaragua for such illegal operations? That goes without saying. They will be looking for the places from where they can easily make (their journey) closer to the USA border. What made the French police suspicious about this chartered flight? Are you in contact with the French police?

The input we got is that they had some hint, input (from their local sources) that people from India were being trafficked -- human trafficked -- through this flight. But when they (the French police) stopped the plane, and all the passengers were interrogated, all were very candid in saying they all were going on a tourist visa. Nobody was being forced, or, nobody was being taken hostage or they were travelling against their will.

After their interrogation and basic inquiry, they sent the plane back (to India). And these people are being questioned now and being treated as victims as of now? Yes, questioning is going on and for technical purposes we are treating them as victims. But that is not necessary; (how we treat them) depends on the process of investigation, who turns approver, who gives what witness, evidences to us and who doesn't cooperate with us.

Under which sections would the investigations be carried on or would the FIRs be filed if at all?We haven't yet drafted the FIR. It will take some time from now. But yes, we will find out the sections (under which to register FIRs against these people); actually the

money flow is huge. Huge money transactions are there (These passengers reportedly were to pay Rs 60 to Rs 80 lakh to agents for their illegal travel to the US). We'll work it out how things (investigations) can move from here. We have good leads also.

Hopefully in the coming few days we'll be able to have clear picture. That picture is clear in our head. But yes, being sensitive, we are not in position to explain it to you. Are you also in touch with the Dubai and French police? Basically, in India, the CBI is the nodal agency in such cases (through which the local police coordinate with international police). We are in touch with CBI and we have sought needful information through CBI from my office. What interesting leads have you got during the investigation?

We have interesting leads on the agents. The roles of agents in this entire operation, who were doing what, etc.We are still interrogating them and getting finer details so that the story becomes pretty clear. What are these people, who you are questioning, telling you? They are telling their stories, their life stories. Why did they want to go to the USA, how their experience (of travelling from India-to-Dubai-to-France) was.

How were they to make the arrangement for Rs 60 lakh to Rs 80 lakh for their travel to the US?Nobody has made any payment. There is no advanced payment. They were supposed to pay after landing in the USA and that too it was not supposed to be a single installment. The arrangement was that they would make this payment (Rs 60 lakh to Rs 80 lakh) over a period of three years. It's like an EMI?

That is like an EMI. As far as Gujarat is concerned, if somebody X from village Y plans to go to the USA then the village people, the elderly, their relatives take the responsibility (to provide financial assistance).(In this case the village elderly could have assured the agents that) He (someone they knew from among the 66 people who were deported) is from a good family and we'll pay your money back after their landing there and we take the responsibility. That is how it works.

These people (who move to the US via such channels), after going to the USA and finding a job there, get good money from their job, and with some amount of help from there and some amount from here (from the village elderly, relatives, etc), sell their ancestral properties, farmlands, jewellery and make arrangements for fulfilling their financial obligations.

But unless and until you land in the USA, you are not supposed to make the payment. That is why these passengers are also not that cooperative to us. Are these travel agents reputed or are they fly-by-night travel agents? They have very a good name as far as the passengers going to the USA are concerned (the passengers who were on board that flight headed to Nicaragua shared a good relationship with these agents).

There are domain experts also, but it is not that everybody is involved in sending people to the USA illegally. There are people who are going out legally also. How many people from Gujarat were there on this flight?

We have about 66 people from Gujarat and we have questioned all these 66 people. These people from Gujarat belong to Anand, Gandhinagar, Mehsana, Patan and Banaskantha district, which borders Rajasthan.

ut yes, for the time being it is also kind of sensitive. Actually there are many agencies involved like the ministry of external affairs, foreign embassies like the French embassy and Dubai (United Arab Emirates) embassy. Sharing of information is very critical in this aspect. People will think at least ten times before sharing any information. It should not bring an embarrassment to the government.

The ministry said it will provide a financial support of up to Rs 2 lakh on each judicial colloquium to be held anywhere in the country.

The home ministry said the result of globalisation has increased the movement of people in search of better opportunities which often makes them victims of trafficking and leads to their exploitation by unscrupulous elements. "Such exploitation can be in several forms such as labour, prostitution, forced marriages, domestic servitude, begging, organ trade, drug couriers, arms smuggling etc," it said.

The home ministry said victims of trafficking often endure extreme hardship -- physical violence, sexual abuse, harassment, threat and coercion are some common experiences of trafficked persons. Some victims lose their lives at the hands of ruthless traffickers who exploit their vulnerabilities, it said, adding the complex nature of the crime calls for a multi-dimensional strategy to tackle it at domestic, regional and international level, it said.

The home ministry said strengthening cooperation and establishing interstate channels of communication and with neighbouring countries can be an effective tool in countering trafficking. It said the impediments which the government has come across in the past include lack of awareness, lack of training of concerned officers, failure to register cases under relevant laws and ineffective investigation etc.

The government feels the problem of trafficking can be addressed to a large extent with regular exchange of information through designated focal points, sensitisation of police officers, judicial officers, border guarding officials and partnership with civil society organisations, the ministry said. It listed other suggestions such as organising capacity building programmes of concerned officials, monitoring activities of private placement agencies and travel agents etc., and disseminating information to vulnerable sections of society.

The home ministry said to meet the objective of sensitising the judicial officers of states and UTs on wide-ranging issues relating to trafficking in persons, it has been engaging with the judicial academies of states and UTs for holding judicial colloquiums on anti-

human trafficking on periodic basis. "You are requested to arrange to hold judicial colloquium on anti-human trafficking in your state/UT..," it said. PTI ACB TIR TIR

CCB busts another prostitution racket, rescues 44 women

Bengaluru: The Central Crime Branch (CCB) of police busted a prostitution racket, which was allegedly operating in the city under the pretext of a spa lounge, during a raid at a multi-storied building in Mahadevapura here. The CCB sleuths conducted raids at several places in Bengaluru on Saturday based on credible information from the state intelligence.

Earlier, a case had been registered at the Mahadevapura Police Station in connection with a human trafficking racket. Intensifying a probe into the matter, the CCB officials identified several places and raided them. The racket was busted when the police searched a multi-storeyed building in Mahadevapura.

A total of 44 women, belonging to Karnataka and other places including foreign nations, were rescued, the police said. Following the operation, the Mahadevapura police took 34 people into custody and arrested the main accused, identified as Anil. A senior official said that the officers of CCB's Women's Protection Wing conducted the raid for about four hours late on Saturday night in the said building after receiving a tip-off about the illegal racket.

According to sources, Anil was running the fake spa business on the first and sixth floors of the building. During investigations, the accused revealed that young women from the state and outside the country were forced to get involved in the flesh trade. The police added that the main accused shifted to Bengaluru from another state and was running the spa.

A month ago, an under-trial prisoner, who was also running a prostitution racket in Bengaluru from Parappana Agrahara jail, was arrested by the police along with three others. The police arrested Manjunath alias Sanju, who was lodged at the Parappana Agrahara jail here.

Sanju, his accomplices Arun, Raghavendra and Darshan were also arrested for their role in running the prostitution racket, sources said. Sanju used to connect with clients through an app while still in jail.

NLFT militant surrenders before BSF in Tripura's Dhalai

An NLFT militant surrendered before the BSF in Tripura's Dhalai district, officials said on Monday. The 37-year-old man, identified as Uday Manik Jamatia, surrendered before the BSF in the district's Chawmanu area on Sunday, they said.

Due to efforts of the central agencies and state authorities, several National Liberation Front of Tripura (NLFT) cadres have left the path of violence, he added. The surrendered militant will be handed over to the police for interrogation and other legal process, the official said.

The outfit's top leaders, Sachin Debbarma and Utpal Debbarma, were arrested from West Tripura's Simna area on December 14, in a major jolt to the group.

Rule of law does not mean protection to a fortunate few: Justice Nagarathna

The Supreme Court in the Bilkis Bano judgment on January 8 held that personal liberty gained through the breach of law cannot be protected. A Bench headed by Justice B.V. Nagarathna said that the rule of law was quintessential for personal liberty or any other fundamental right to exist and flourish.

In a message to the judiciary, Justice Nagarathna, who is in line to be the first woman Chief Justice of India according to the seniority norm, emphasised that "those concerned with the rule of law must remain unmindful and unruffled by the ripples caused by it".

"Rule of law does not mean protection to a fortunate few. The very existence of the rule of law and the fear of being brought to book operates as a deterrent to those who have no scruples in killing others if it suits their ends," the judge observed.

The Bench was dealing with a plea by the convicts to invoke its extraordinary powers under Article 142 of the Constitution to let them remain free despite the cancellation of the order for their remission in August 2022.

"Article 142 of the Constitution cannot be invoked by us in favour of respondents to allow them to remain out of jail as that would be an instance of this court's imprimatur to ignore rule of law and instead aid persons who are beneficiaries of orders, which in our view, are null and void and therefore non est in the eye of law," Justice Nagarathna reasoned.

The judge said the "courts have to dispense justice and not justice being dispensed with". "In fact, the strength and authority of courts in India are because they are involved in dispensing justice. It should be their life aim," Justice Nagarathna observed.

The judge said there is no room for compassion or sympathy when the rule of law has to be enforced. The courts should be dispassionate, objective and analytical.

Everyone within the framework of the rule of law must accept the system, render due obedience to orders made and in the event of failure of compliance, the rod of justice must descend down to punish, Justice Nagarathna stressed.

Curb the disillusionment with the traditional rule of law

The essential condition for the continued trust in the rule of law is the faith in the inherent "goodness" or desirability of the "norm" that sets the boundaries between right and wrong. We are all taught about the virtues of a "norm"-abiding life. The 'guru' must be respected because he teaches us the "norms".

In the modern secular context we are told to respect the fundamental norm, the Constitution of India. Even the father of the nation, M.K. Gandhi, considered the normative raison d'etre sacrosanct. For him, a duly enacted law needed to be respected. But he also said that it was the moral duty of a citizen to oppose an unjust law by all democratic means.

The Dandi March, a mass civil disobedience movement undertaken by Gandhi against the salt tax, set an example for the respect for "norms" when he agreed to be willingly subjected to criminal proceedings for breaking the law. But, today, the rule of law faces a new credibility crisis and the normative raison d'etre subjected to disillusionments of, at least, two kinds. The first is those arising out of the out-datedness or infirmities in the law/laws, and the second, those arising out of an altered perception of law itself that treats law as a "power resource", which can be moulded as per the social requirements. Decriminalisation of penal laws

As a part of smart governance, the present government has addressed the problem of infirmities and out-datedness in laws by suitable amendments in the laws and their updation to a large extent. After a detailed identification of the problematic laws, in the first phase, the Jan Vishwas (Amendment of Provision) Act, 2023 was passed to bring about changes in 42 central Acts of varied genre, ranging from the Indian Post Office Act, 1898, the Railways Act, 1989, and the Cinematograph Act, 1952.

The Jan Vishwas Act, piloted by the Ministry of Commerce and Industries primarily to achieve the objective of facilitating business activities in the "Statement of objects and Reasons", spelled the objectives: the outdated rules and regulations are anathema to democratic governance; reducing the compliance burden gives impetus to business and improves the cost of living; fear of imprisonment for minor offences is a major factor hampering the growth of the business ecosystem; trust-based governance necessities a rationalisation of monetary penalties and the gravity of the offence.

In the second phase, the colonial period Indian Penal Code, 1860, the Code of Criminal Procedure, 1973 and the Indian Evidence Act, 1872 were replaced by the Bharatiya Nyaya (Second) Sanhita, the Bharatiya Nagarik Suraksha (Second) Sanhita and the Bharatiya Sakshya (Second) Bill, 2023, respectively. These new Indian penal laws have

been envisaged to shed the colonial law legacy and, at the same time, rid the penal laws of infirmities and update them to modern thinking in the field. It is hoped that the rule of law will be able to rebuild the credibility crisis with these laws coming into force.

Crisis of credibility

We all accept and agree about the integrity of the rule of law for a democratic development. Scholars have already identified and underscored the Rule of Law Index as an essential component of the national vision for development in the Viksit Bharat journey.

However, the real credibility crisis of the rule of law is located not so much at the normative level but at the level of the rule of law reality that is constituted by the perception and experiences of the consumers of the law — the victim and the victimiser, the enforcers of the law — the policeman, the courts....Above all, the perceptions and the experiences of those who exercise overall command on the rule of law. The 'command group', that in the contemporary context is constituted by the majoritarian will, decide the ways in which the rule of law is to be understood and used as a power resource.

Policing, through encounters, and now policing through 'bulldozers', has gained currency to replace 'investigation', which involved visiting a scene of crime, interrogation of witnesses, arrest, search and seizure. Often, the encounter and bulldozer methods evoke populist support and appreciation from the administration. But because these shortcuts are neither adequately debated nor subjected to pre-determined democratic checks and balances, there exist huge possibilities of their gross abuse at the ground level. We need to learn from two examples of abuse which led to suffering.

In the first, the shooting of a young car mechanic of Algerian descent led to large-scale violence in several cities in France resulting in police action against thousands of youth mostly of Arab and black origin. The French police asserted that they were "at war with savage hoards of vermins", while the protesters sought "justice" based on respect for principles of legality, necessity, proportionality non-discrimination, precaution and accountability.

The second example was the custodial torture and civilian deaths in the course of security force action and inquiry after the ambush of Army vehicles in Poonch district. A report in a leading daily said: "But the allegations of custodial violence speak of a brutal, unacceptable high-handedness by the security forces. This is not 'Naya Kashmir' that the Centre talks about, these are the worst ghosts of the past. The charges, the circumstances, must be thoroughly investigated and the guilty brought to book."

Looking ahead

The traditional rule of law notion, that is premised on uniformity, predictability and certainty, is crucially hinged upon normative fidelity that requires going through a cycle of processes before arrival at a 'guilty' verdict leading to punishment. As against this, the modern day 'short-cut' or 'abridged' rule of law model looks for quick and reactive

ways for doing repressive justice that focuses more on identifying the targeted accused either on the basis of majoritarian dictate or cryptic information reaching the police or the civic administration.

Since the abridged rule of law does not require going through a fixed cycle of process, the first action itself, i.e., the encounter killing or destruction of property by 'bulldozer' may constitute the final sanction or punishment. Though the abridged rule of law delivers quick and reactive justice, it is crude and makes 'justice' a matter of chance, because it would be difficult to decide with certainty who shall be the next target — as an encounter killing or as the target of bulldozer action.

Fortunately for us, the government of the day continues to repose faith in the traditional rule of law. It is hoped that before it is too late, we should be alert to the dangers inherent in the growing fad for a 'shortcut' or an 'abridged' rule of law model.

Dalit Man Kept Hostage, Beaten To Death Over "Love Affair" In UP: Cops

A 21-year-old Dalit man was allegedly beaten to death by some people after keeping him hostage in a house over his "love affair" in Khatauli police station area of this district.

The incident took place in Jasola village on Sunday night, police said on Monday, adding the victim was identified as Ankit.Khatauli Circle Officer Ravi Shanker told news agency PTI that after getting the information, police rushed to the spot and shifted injured Ankit to a hospital, where doctors declared him dead.

The body has been sent for a postmortem examination, police said, and added that a case has been registered against unidentified accused under Section 302 (murder) of the IPC and relevant sections of the Scheduled Caste and Scheduled Tribe (Prevention of Atrocities) Act.

According to a complaint lodged with police by the Ankit's family, he was kept hostage since Sunday evening in the house over love affair with a woman, the official said.

Ms. Madhavilatha has said that three cents of land had been allocated to his family and an outsourced job to his brother Mr. Suresh, as part of the ex-gratia offered by the State government.

Murder accused jumps off train, dies

Patna: A 19-year-old murder accused, who had escaped from Benipur jail in Darbhanga last year and was arrested in Delhi, jumped off a moving train and died in a bid to escape police custody Saturday night. The incident took place near Sarai Bhupat railway station on Delhi-Howrah line when Sonu Das was being brought back by Swatantrata Senani Express.

Das was accused of a dowry murder case registered with Bahera police in Darbhanga. SHO Brajesh Kumar said Das had asked police to free his hand on the pretext of going to toilet. The train, running at a speed of approximately100km/hr, approached the Sarai Bhupat railway station and he jumped off it, hit a pillar and died. "SI Ranjit Singh and constable Satish Kumar, who were with him, pulled the chain. Etawah GRP recovered the body and started further legal action," he said.

The SHO said Das was sent to Benipur jail on June 4, 2023. He escaped on July 10 and fled to Delhi. "An FIR was lodged at Bahera police station. Just a few days ago, we came to know about Das's whereabouts and contacted Delhi police. We arrested him on Thursday," the SHO added.

The police team then reached Das's home with the body but the family members refused to accept it, demanding compensation from the railways. After a lot of efforts by the police and administration, the protesting family members agreed to cremate the body. The incident occurred near Sarai Bhupat railway station in UP's Etawah district early on Friday around 2.30am. विदिशा जिले के सिराेंज क्षेत्र में दबंगों के हमले में घायल दलित युवक की रिववार को मौत हो गई। इससे गुस्साए परिजनों ने सोमवार को थाने के सामने प्रदर्शन किया। लोगों का आरोप है कि इस मामले में पुलिस ने एकतरफा कार्रवाई की है।

पुलिस ने आरोपियों पर हत्या की धारा बढ़ाने का आश्वासन दिया। सख्त कार्रवाई के आश्वासन के बाद परिजन मान गए। हमले घायल युवक की पत्नी अभी भोपाल में भर्ती है। भोपाल रोड पर स्थित बरखेड़ी गांव में 2 जनवरी को नल से पानी भरने की बात पर दो पक्षों में मारपीट हो गई थी। इसमें दबंगों ने करन अहिरवार की लाठी डंडों और फरसों से मारपीट कर दी।

दबंगों के नल से पानी भरने पर पीटा

परिजनों ने बताया कि गांव में दिलतों का नल अलग है। इस बार कम बारिश के कारण उसमें पानी नहीं आ रहा। इस पर करन गांव के दूसरे नल पर पानी भरने चला गया। गांव के यादव समाज के लोगों ने इस पर आपित्त ली। उन्होंने करन की मारपीट कर दी। एफआईआर के अनुसार गांव के सोनू यादव ने पानी भरने को लेकर करन से गालीगलौज कर दी। उसे थप्पड़ मार दिए। कुछ देर बाद सोनू के साथ कई लोग लाठी-फरसे लेकर उसके यहां पहुंचे। उन्होंने करन पर हमला कर दिया।

हमले में करन अहिरवार के सिर में गहरा घाव हो गया। करन की पत्नी गुमान बाई के हाथ में भी गंभीर चोटें आई थी। दोनों को भोपाल रेफर किया था। रविवार रात करन की इलाज के दौरान भोपाल में मौत हो गई। गुमान का इलाज भोपाल में चल रहा है। झगड़े में यादव समाज के लोग भी घायल हुए थे। इस मामले में पुलिस ने क्रॉस केस दर्ज किया है।

घटना के बाद 2 दिन गांव में पुलिस भी तैनात रही थी। करन की मौत के बाद लोगों ने प्रदर्शन किया। करन के परिजनों का आरोप है कि यादव समाज के लोगों ने गुट बनाकर हमलाकर दिया। महिलाओं और बच्चों तक को पीटा। दबंग उसकी जमीन छुड़ाना चाहते हैं। इसलिए यह वारदात की गई है।
