

Delhi sewer death: NHRC asks CS, Police Commissioner to submit report within two weeks

Taking suo motu cognizance of the reported death of one worker and serious injuries to three others while cleaning sewer in Ashok Vihar area of North West Delhi, the National Human Rights Commission (NHRC) on Monday issued notices to the Delhi Chief Secretary, Municipal Commissioner and Police Commissioner and askedthem to submit detailed report on the matter within two weeks.

The rights commission said that the detailed report should include the status report of the investigation, health of the injured workers as well as the compensation paid to the next of kin of the deceased and to the injured workers.

"The National Human Rights Commission (NHRC), India has taken suo motu cognizance of a media report that one worker died and three others were critically injured while cleaning sewer in Ashok Vihar area of North West Delhi on 16th September, 2025," the rights panel said in a statement.

The Commission said reportedly, their co-workers stated that no safety equipment was provided by the private construction company which engaged them for cleaning the sewer. The rights panel has observed that the contents of the media report, if true, raise a serious "issue of human rights violation". "In spite of directions given by the Supreme Court and NHRC advisory issued to all the States / Union Territories to ensure safety of the sanitation workers, such tragic incidents are occurring frequently. Therefore, it has issued notices to the Chief Secretary, Government of NCT of Delhi, Commissioner, Municipal Corporation and Police Commissioner, calling for a detailed report on the matter within two weeks." the statement said.

"It is expected to include the status of the investigation and health of the injured workers. The details of compensation paid to the next of kin of the deceased and to the injured workers have also been sought," it said.



NHRC takes cognisance of Ashok Vihar sewer tragedy


It is expected to include the status of the investigation and the health of the injured workers.

The details of compensation paid to the next of kin of the deceased and to the injured workers have also been sought, the statement said.

According to the media report, carried on September 18, the police control room had received a call late in the night on September 16 regarding the incident.

The police rushed all four victims to the Deen Dayal Upadhyay Hospital. Doctors declared one of them as 'brought dead', while the three others were admitted to the ICU in a critical condition. The manager of the company is being questioned, it said.







Death of man while cleaning sewer: NHRC issues notice

The National Human Rights Commission (NHRC) on Monday issued notices to the Delhi government over the death of a 40-year-old man and injuries to three others while cleaning a sewer in Ashok Vihar. The incident was reported to the police on the night of September 16. All four workers were rushed to a hospital, where one was pronounced dead on arrival and the others admitted to the ICU in a critical condition.

Terming the case a "serious violation" of human rights, the NHRC asked the government to submit a detailed report on the issue within two weeks.

NHRC seeks report on sanitation worker's death in Ashok Vihar

The National Human Rights Commission (NHRC) has taken suo motu cognisance of the death of one sanitation worker and serious injuries to three others while cleaning a sewer in Delhi's Ashok Vihar area on September 16.

The commission issued notices to the Delhi Chief Secretary, the Municipal Commissioner and the Delhi Police Commissioner, asking them to submit a comprehensive report on the incident within two weeks. The report has to include details

on the status of the police investigation, the health condition of the injured workers and, compensation for the deceased worker's family and those injured.


According to the NHRC, the case raises concerns of human rights violations. "In spite of the Supreme Court's directions and the NHRC's advisory to all the states and the Union Territories to ensure safety of the sanitation workers, such tragic incidents are occurring frequently," the commission noted.

The incident came to light after media reports on September 18 stated that four men were engaged by a private construction company for cleaning a sewer in Ashok Vihar without being provided safety equipment. Late on the night of September 16, a call was made to the Police Control Room regarding the situation.

Police personnel rushed the four workers to Deen Dayal Upadhyay (DDU) Hospital. One of them was declared brought dead by doctors, while the other three were admitted to the Intensive Care Unit in critical condition. The company manager responsible for deploying the workers has been questioned, police said.

Now, the Supreme Court, in earlier judgments, had directed governments to mechanise sewer cleaning and provide protective equipment to sanitation workers where manual entry was unavoidable.

But the issue of sanitation workers dying on job seems to have continued unchecked for as per data released by the National Commission for Safai Karamcharis (NCSK), on average, one sanitation worker has died every fifth day cleaning sewers or septic tanks since 2017.

NHRC takes suo motu cognisance, seeks report in Ashok Vihar sewer death

THE National Human Rights Commission (NHRC) has issued notices to the Delhi government, the Municipal Corporation of Delhi (MCD) and the city police commissioner over the death of a worker while cleaning a sewer in Northwest Delhi's Ashok Vihar earlier this month.

The commission said it has taken suo motu cognisance of a media report, noting that despite repeated directions by the Supreme Court and advisories by the NHRC itself, sanitation workers continue to die in unsafe working conditions.

"Such tragic incidents are occurring frequently," the panel observed, adding that the media report, if accurate, points to a "serious issue of human rights violation."

According to the report, the workers had been engaged by a private construction company for cleaning work. Their colleagues alleged that they were not provided with any protective gear before entering the sewer. Police had rushed all four workers to Deen Dayal Upadhyay Hospital, where one of them was declared "brought dead", while the other three were in critical condition.

The NHRC has directed the Delhi chief secretary, the MCD commissioner and the police commissioner to submit a detailed report within two weeks.



The report is expected to cover the status of the police investigation, the health condition of the injured workers and details of compensation offered to the deceased worker's family as well as to the survivors.

The rights body has also asked for clarification on the role of the private construction company, whose manager is

currently being questioned by the police.

It reiterated that ensuring safety standards for sanitation workers is the responsibility of state authorities and municipal bodies, as mandated by the Supreme Court and reinforced through NHRC advisories.

The commission stressed that accountability must be fixed to prevent recurrence of such deaths, which continue to highlight the vulnerability and unsafe working conditions of sanitation workers across the country.



NHRC: Act against Ranbir, Netflix over vaping scene in series

The National Human Rights Commission (NHRC) has issued notices to the Ministry of Information and Broadcasting and the Mumbai Police following a complaint about a Netflix web series. The complaint alleges that actor Ranbir Kapoor was shown using a banned e-cigarette (or vape) in an episode of "The Ba***ds of Bollywood" without any warning or disclaimer.

Filed by Vinay Joshi of the Legal Rights Observatory, the complaint argues that this depiction glamorises an illegal product and could negatively influence young viewers, thereby violating Indian law and harming public health.

The NHRC, acting under the Protection of Human Rights Act, 1993, observed that the allegations amounted to serious violations of law. It observed that the scene appeared to contravene the Prohibition of Electronic Cigarettes Act, 2019, which banned the storage, use and promotion of e-cigarettes.

The Bench presided over by member Priyank Kanoongo has directed the I&B Secretary to take appropriate action to prohibit such content immediately. The Mumbai Police Commissioner has been asked to investigate the roles of the actors, producers and Netflix, which includes identifying the manufacturers and importers of the ecigarettes used.

This investigation could lead to an FIR being lodged against Kapoor, the production house and the streaming platform. Both authorities have been given two weeks to submit an action taken report to the Commission.



NHRC notices over death of worker while cleaning sewer

"In spite of directions given by Supreme Court and NHRC advisory issued to all the states and UTs to ensure safety of the sanitation workers, such tragic incidents are occurring frequently," it said in a statement.

It said the report to be submitted by the authorities must include the status of investigation, health of the injured workers, and compensation paid to the next of kin of the deceased and to the injured workers.

Vaping: NHRC notice to Ranbir Kapoor, Netflix

New Delhi: The National Human Rights Commission (NHRC) has directed the Mumbai Police Commissioner to initiate appropriate legal action, including the lodging of an FIR, against actor Ranbir Kapoor, producers of the web series 'Ba***ds of Bollywood', and the OTT platform Netflix over promotion of banned ecigarettes. A Bench presided by NHRC member Priyank Kanoongo took cognisance of a complaint filed by Vinay Joshi of the Legal Rights Observatory, who alleged that 'Ba***ds of Bollywood' (Season 1, Episode 7) showed the actor using a prohibited e-cigarette on screen without any warning or disclaimer.

The complainant claimed that such content negatively influences young viewers, promotes illegal activities, disrespects law enforcement, and harms public health and morality. In its notice issued under the Protection of Human Rights Act, 1993, the apex human rights body observed that the allegations, if true, amount to a prima facie violation of Sections 4 and 7 of the Prohibition of Electronic Cigarettes Act, 2019.

The apex human rights body has called for an Action Taken Report (ATR) from all authorities within two weeks.

NHRC: Act against Ranbir, Netflix over vaping scene in series

The National Human Rights Commission (NHRC) has issued notices to the Ministry of Information and Broadcasting and the Mumbai Police following a complaint about a Netflix web series. The complaint alleges that actor Ranbir Kapoor was shown using a banned e-cigarette (or vape) in an episode of "The Ba***ds of Bollywood" without any warning or disclaimer.

Filed by Vinay Joshi of the Legal Rights Observatory, the complaint argues that this depiction glamorises an illegal product and could negatively influence young viewers, thereby violating Indian law and harming public health.

The NHRC, acting under the Protection of Human Rights Act, 1993, observed that the allegations amounted to serious violations of law. It observed that the scene appeared to contravene the Prohibition of Electronic Cigarettes Act, 2019, which banned the storage, use and promotion of e-cigarettes.

The Bench presided over by member Priyank Kanoongo has directed the I&B Secretary to take appropriate action to prohibit such content immediately. The Mumbai Police Commissioner has been asked to investigate the roles of the actors, producers and Netflix, which includes identifying the manufacturers and importers of the ecigarettes used.

This investigation could lead to an FIR being lodged against Kapoor, the production house and the streaming platform. Both authorities have been given two weeks to submit an action taken report to the Commission.

tion from the ministry or over-the-top platform Netflix, The National Human Rights Commission has said that authorities be directed to get the allegations levelled in the com plaint, be inquired into, and an "action taken report" be submit-



ted within two weeks for perus-al of the Commission.

A bench of the NHRC, presided by its member, Priyank Kanoongo, has taken cognisance under Sections 12 of the Protection of Human Rights Act, 1934, the proceedings says.

"Furthermore, this incident is in clear violation of Sections 4 read with Section 7 of the Prohibition of Electronic Cigarettes Act, 2019. It is pertinent to mention here that Section 4 readblists the actoremy see, and prohibits the storage, use, and promotion of e-cigarettes in any form, and Section 7 pena-lises individuals and companies that advertise or promote such banned products," it adds.

The registry has been di-rected to issue a notice to the

secretary of the Ministry of Information and Broadcasting, to "take appropriate action and im-mediately prohibit such content which may wrongly influence

the young generations'.

The notice is also marked to commissioner of police of Mum-bai, regarding "initiation of in-vestigation into the identity and operations of manufacturers and importers of electronic cig-arettes, and for taking appropriate legal action including lodg-ing of an FIR as per laid down procedures against actor Ranbir Kapoor and other individuals/ companies including the pro-ducers/production company, OTT platform Netflix, involved in the advertisement, depiction, or promotion of the same in contravention of the Prohibition of Electronic Cigarettes Act, 2019 and other applicable criminal laws," it says.





The six-day Indian Technical and Economic Cooperation (ITEC) Executive Capacity Building Programme on human rights for National Human Rights Institutions (NHRIs) of the Global South began in New Delhi today. The programme is being organised by the National Human Rights Commission (NHRC), India, in collaboration with the Ministry of External Affairs (MEA). It has brought together 43 senior-level functionaries from 12 NHRIs of Mauritius, Jordan, Georgia, Philippines, Qatar, Fiji, Uzbekistan, Bolivia, Nigeria, Mali, Morocco and Paraguay. Designed to strengthen the institutional capacities of NHRIs of the Global South, the programme underscores NHRC India's commitment to fostering global dialogue on human rights, advancing South-South cooperation and promoting rights-based governance.

Inaugurating the programme, NHRC, India Chairperson, Justice Shri V. Ramasubramanian, reflected on the current global landscape. He observed that today's world is marked by protests, anger, frustration, inequality, uncertainty and political unrest.

Citing an international think tank-Carnegie's Global Protest Tracker Report, he noted that in the past year alone, more than a hundred protests erupted in various parts of the world, driven by factors such as anger, frustration, abuse of power, perceived government corruption and suppression of media. Between 2022 and 2025, protests even toppled governments in three of India's neighbouring countries. He said that the significant point to note was that in countries where human rights institutions are very strong, such protests did not escalate into violence. These institutions act as safety valves for public discontent. Unfortunately, in some countries, human rights institutions are perceived as being anti-government, while they actually are people friendly.

Justice Ramasubramanian further highlighted India's unique cultural diversity with its various religious faiths, castes, languages, dialects and art forms, all thriving together in unity through shared traditions and values. He also noted that Global South nations have rich traditions and unique experiences in addressing human rights issues. NHRC, India through ITEC Executive Capacity Building Programmes, seeks to provide a forum to learn together, share and grow together, in keeping with the spirit of the Vedic ethos of Vasudhaiva Kutumbakam i.e. the world as one family.

Earlier, in his opening remarks, NHRC, India Secretary General, Shri Bharat Lal, emphasised that human rights are always evolving and not static. He underlined India's tradition of sharing knowledge and wisdom for the greater good of humanity. This training programme has been designed with the expectation of mutual learning on issues of common concern across the Global South. These challenges may span diverse areas from energy security and climate change to cyber security and emerging technologies like artificial intelligence. He called upon the Global South to unite in advancing socioeconomic and human development to secure collective well-being and expressed the hope that the interactive sessions would help identify emerging challenges of global relevance.

Welcoming the participants, Shri Samir Kumar, Joint Secretary, NHRC, outlined the programme structure and interactive sessions to follow. The delegates expressed their gratitude and appreciated the role of NHRC, India in providing this opportunity for multilateral dialogue on global human rights issues. Smt. 

The National Human Rights Commission (NHRC), India in collaboration with the Ministry of External Affairs (MEA), is organising a six-day Indian Technical and Economic Cooperation (ITEC) Executive Capacity Building Programme on human rights for senior-level functionaries of the National Human Rights Institutions (NHRIs) of the Global South in New Delhi from 22nd to 27th September, 2025. The programme aims to strengthen the capacities of National Human Rights Institutions (NHRIs) from the Global South. This reflects NHRC India's ongoing commitment to global human rights dialogue, South-South cooperation and the collective advancement of rights-based governance.

This customised programme has been developed in accordance to the need of NHRIs of participating countries and feedback provided during the three earlier ITEC capacity building programmes organised by the Commission. Senior level functionaries from 12 NHRIs from Mauritius, Jordan, Georgia, Philippines, Qatar, Fiji, Uzbekistan, Bolivia, Nigeria, Mali, Morocco and Paraguay are likely to attend the programme.

Drawing from NHRC India's experience of over three decades, the programme seeks to promote deeper understanding, mutual learning and meaningful collaboration among NHRIs for advocacy, enforcementand institutional strengthening across the Global South. Eminent persons with domain knowledge and expertise in capacity building and imparting training will be the resource persons. The programme will be inaugurated by Chairperson of the NHRC, India Justice V. Ramasubramanian.

The expected outcome includes developing a better understanding of international dimensions of human rights; a deeper understanding of NHRC, India's work in the field of human rights protection and its best practices, which can be adopted by the other NHRIs; improved networking among NHRIs, fostering collaborations and partnerships at regional and international levels; and enhanced capability to contribute towards the protection and promotion of human rights.

He also noted that Global South nations have rich traditions and unique experiences in addressing human rights issues. NHRC, India, through ITEC Executive Capacity Building Programmes, seeks to provide a forum to learn together, share and grow together, in keeping with the spirit of the Vedic ethos of Vasudhaiva Kutumbakam, i.e. the world as one family.

Earlier, in his opening remarks, NHRC, India Secretary General, Bharat Lal, emphasised that human rights are always evolving and not static. He underlined India's tradition of sharing knowledge and wisdom for the greater good of humanity. This training programme has been designed with the expectation of mutual learning on issues of common concern across the Global South. These challenges may span diverse areas from energy security and climate change to cyber security and emerging technologies like artificial intelligence.



National Commission for Safai Karamcharis says one worker has died on job every fifth day since 2017

The National Human Rights Commission (NHRC) has taken suo motu cognisance of the death of one sanitation worker and serious injuries to three others while cleaning a sewer in Delhi's Ashok Vihar area on September 16.

The commission issued notices to the Delhi Chief Secretary, the Municipal Commissioner and the Delhi Police Commissioner, asking them to submit a comprehensive report on the incident within two weeks. The report has to include details on the status of the police investigation, the health condition of the injured workers and, compensation for the deceased worker's family and those injured.

According to the NHRC, the case raises concerns of human rights violations. "In spite of the Supreme Court's directions and the NHRC's advisory to all the states and the Union Territories to ensure safety of the sanitation workers, such tragic incidents are occurring frequently," the commission noted.

The incident came to light after media reports on September 18 stated that four men were engaged by a private construction company for cleaning a sewer in Ashok Vihar without being provided safety equipment. Late on the night of September 16, a call was made to the Police Control Room regarding the situation.

Police personnel rushed the four workers to Deen Dayal Upadhyay (DDU) Hospital. One of them was declared brought dead by doctors, while the other three were admitted to the Intensive Care Unit in critical condition. The company manager responsible for deploying the workers has been questioned, police said.

Now, the Supreme Court, in earlier judgments, had directed governments to mechanise sewer cleaning and provide protective equipment to sanitation workers where manual entry was unavoidable.

But the issue of sanitation workers dying on job seems to have continued unchecked for as per data released by the National Commission for Safai Karamcharis (NCSK), on average, one sanitation worker has died every fifth day cleaning sewers or septic tanks since 2017.

By then four men, involved in sewer cleaning, were rushed to Deen Dayal Upadhyay (DDU) Hospital and one of them succumbed, allegedly due to inhaling toxic gases. Three others were admitted to the Intensive Care Unit are in a critical condition.

During interrogation, the co-workers of the victims claimed that "no safety equipment" was provided by the private construction company that engaged them for cleaning the sewer.

Observing that the incidents raise a serious issue of human rights violations, the NHRC issued notices to the Chief Secretary, Government of NCT of Delhi, Municipal Corporation, and the Police Commissioner, demanding a detailed report on the matter within two weeks.

NHRC instructed that the report should include the status of the investigation and the health condition of the injured workers. Besides, the commission also sought details of compensation paid to the next of kin of the deceased and to the injured workers.

"Despite directions given by the Supreme Court and NHRC advisory issued to all the States/ Union Territories to ensure safety of the sanitation workers, such tragic incidents are occurring frequently," the commission noted.

The Commission has "taken suo motu cognisance of a media report that one worker died and three others were critically injured while cleaning a sewer in Ashok Vihar area of North West Delhi on September 16", it said.

Reportedly, their co-workers said that allegedly no safety equipment was provided by the private construction company which had engaged them for cleaning work, the statement said.

The Commission has observed that the content of the media report, if true, raises a serious issue of human rights violation.

Therefore, it has issued notices to the chief secretary, government of Delhi, commissioner of the Municipal Corporation of Delhi and the city police commissioner, seeking a detailed report in two weeks.

It is expected to include the status of the investigation and the health of the injured workers. The details of compensation paid to the next of kin of the deceased and to the injured workers have also been sought, the statement said.

According to the media report, carried on September 18, the police control room had received a call late in the night on September 16 regarding the incident.



35 Undertrial Prisoners Died In State Jails In Past One Year: Odisha CM

Bhubaneswar: Chief Minister Mohan Charan Majhi on Monday informed the Odisha Assembly that as of August 31, 2025, a total of 18,685 prisoners were incarcerated across the state's jails. This includes 4,234 convicted prisoners and 14,451 undertrial prisoners.

Replying to a question raised by BJP MLA from Chhendipada, the Chief Minister said that 35 undertrial prisoners have died in different jails of the state over the past one year.

He clarified that in all such cases, inquiries are conducted by the concerned Judicial Magistrates, and reports are submitted to the National Human Rights Commission (NHRC). Lawful compensation is provided to the families of the deceased prisoners as per NHRC directions. However, in the past year, the state has not received any specific directions from the NHRC regarding compensation in these deaths.

On specific cases, Majhi informed that in the current year, two undertrial prisoners died in Ranibania Model Jail at Khuntuni. While no complaints have been received against anyone in connection with these deaths, judicial inquiries are underway. He added that the state government will take necessary action once NHRC directions, if any, are issued based on the inquiry reports.

Nimdih, Jharkhand: "It was around 11 pm when we were jolted out of sleep by knocking sounds. On opening the door, a few policemen rushed in and started beating us. They were here to arrest Sambika didi. One of them grabbed me by the hair and verbally abused me when I asked why my sister was being taken into custody," recalled Roboni Kora, the younger sister of Sambika Kora.

The incident occurred at Ramnagar under Nimdih Police Station in Jharkhand's Saraikela-Kharsawan district on March 25, 2022. Sambika, then 19, was taken into custody over a land dispute in the family and was released around 8 am the next day, after her husband was called to the police station. Around 9 am, the couple was dropped off in Balidih village.

The arrest violated Section 160 of the Code of Criminal Procedure (now Section 179 of Bharatiya Nagarik Suraksha Sanhita (BNSS), stipulating that no woman of any age should be required to attend any place other than their residence for interrogation. Also, no record of an FIR or complaint registered was available concerning her custody. No paperwork was done at the time of release as well.

Roboni said that she had asked if the officers possessed an arrest warrant. "They refused to offer any explanation. My mother was also interrogated and verbally abused, but we somehow escaped and took shelter in a school in the nearby village. They did not even spare our grandmother. She was also taken with my sister, but deboarded after some distance," added Roboni, who was 16 at the time of the incident.

As per her complaint to the National Human Rights Commission (NHRC), Sambika claimed that she was locked up in custody, with the policemen verbally abusing her until dawn. There were no women police on duty. She was even denied water to drink.

Roboni told this reporter that her sister was beaten with shoes, but that was not mentioned in Sambika's statement to NHRC.

Twisted truth

Police stations are meant to be spaces where anyone can file a complaint, but a majority of women are afraid to report a crime, fearing further mistreatment. In Sambika's case, the police station became the site of crime. Sambika was advised by a resident of Ramnagar, who does not want to be named, to meet Vishwajit Karmakar, an advocate in Civil Court, Ranchi, and also a member of the Network of Advocates for Rights and Action.

On March 28, 2022, Karmakar lodged an online complaint to the NHRC on Sambika's behalf. "As per the complaint, Sambika was brought to the jail without any coherent reason, contravening the provisions of BNSS. As per Section 179 of BNSS, her statements can only be recorded where she resides in the presence of a woman constable and family members. In case she has to be arrested, the police should have orders from the magistrate," explained Karmakar.

"It was a civil matter between Sambika's family and her paternal uncle, and the police came at the uncle's behest," added Karmakar. In civil cases, the police have no authority to resolve disputes. They can intervene only in situations where criminal activity or a threat to peace is involved. Sambika protested the most against illegal detention that night, so she was taken into custody.

However, when contacted, Sambika refused to share details of the family dispute with this reporter.

Taking note of the complaint, NHRC on April 4, 2022, directed its registry to transmit a copy of the complaint to the superintendent of police (SP), Saraikela-Kharsawan district, and submit a response within four weeks.

Pursuant to the same, SP sent a report to the NHRC on September 3, 2022. The report submitted by the sub-divisional police officer of Chandil, Jharkhand, carried statements of policemen at Nimdih station. The statements recorded on April 30, 2022, stated that a domestic quarrel occurred between Sambika and her husband on March 25, 2022, which led to police intervention. They claimed that the police did not abuse them, but they were taken to a nearby public health centre for treatment as they had suffered injuries during the quarrel. After counselling, they were taken back to their home in a police van.

Subsequently, on September 19, 2022, NHRC directed Sambika to submit her response regarding the police statement. On September 30, 2022, Sambika, in her response, denied their statement and reiterated allegations against the police. The NHRC then directed the SP on December 9, 2022, to further investigate the matter. On March 15, 2023, the SP again submitted a report observing that there was a lapse on the part of the station house officer (SHO) as he kept a woman in the police station premises in the wee hours without any coherent reason.

"The police have framed these lies to defend themselves. They could not attach any report from the hospital or produce any statement from the doctor. There was also no injury report or the mention of the kind of treatment given," Karmakar said.

The NHRC found a lapse on the part of the SHO, so they directed the SP to again submit a report on April 17, 2023. The SP submitted a report on September 27, 2023, stating that the departmental inquiry against the then sub-inspector, Amit Kumar Gupta, was completed and he was found guilty, so his salary increment for six months has been suspended. Curiously, only the sub-inspector was found guilty and no action was taken against SHO, without whose permission the incident would not have happened.

After the suspension, the NHRC issued a show cause notice regarding compensation to the Jharkhand Chief Secretary on April 29, 2024, stating that although the sub-inspector was duly punished, the state was vicariously liable for his action. It said the NHRC considered the case fit for Rs 1.5 lakh compensation under Section 18 of the Protection of Human Rights Act, 1993. The notice clearly stated that in case of non-compliance, the case would be reopened after six weeks. Due to the non-compliance, the NHRC reopened the case on February 20, 2024.

On May 13, 2024, the NHRC received a copy of the communication from the under secretary, Home, Jail and Disaster Management Department, Government of Jharkhand, addressed to the accountant general, Jharkhand, wherein it is maintained that the recommendation of compensation of Rs 1.50 lakh has been sanctioned. The said copy has also been addressed to the deputy commissioner, Seraikela-Kharsawan, with a direction to make payment to Sambika. However, the compliance report of payment is still awaited.

Fight for justice continues

Sambika's abuser was suspended only because of NHRC intervention. Karmakar had filed the case directly to the NHRC and not to the Jharkhand State Human Rights Commission because the state wing had remained inactive since COVID-19 period.

"For families like Sambika's, NHRC is a great forum as one can register their complaint online free of cost as compared to the courts where one has to be physically present to file the petition, and then the case gets forwarded. Once a person complains, the commission verifies from their end and directs an inquiry. Hence these forums are best for economically weaker sections of society," said Karmakar.

However, when it comes to punishment, are suspensions enough? They are swift, more aimed at appeasing public anger than delivering real accountability. "To address such incidents, we need stringent legal reforms, institutional accountability, gender sensitisation training and a broader cultural shift within the police force," emphasised Karmarkar.

Meanwhile, Sambika's fight for justice continues as she is yet to receive the compensation. Though both NHRC and SHRC can investigate and decide on

compensation, their power is usually advisory, with no authority to take direct action or impose penalties.

Additionally, the delay in compensation stems from a combination of reasons such as institutional apathy, systemic bias, legal complexities and bureaucratic inefficiencies. Lack of timely action contributes to the prolonged suffering of victims.

Sambika was never formally charged with any crime. She knew why she was taken into custody. This incident particularly did not affect the civil case in her family, as there was no formal complaint registered against the uncle, which underscores a broader societal problem where abuse is normalised within families.

Sambika is grateful for the justice she received from NHRC, and is hopeful that one day she will receive the compensation as promised.

Meanwhile, Mumbai Police have been instructed to probe the manufacturers and importers of e-cigarettes, with a report expected within two weeks.

Aryan Khan's web series has been in the spotlight for its storyline and star-studded cast. 'The Ba***ds of Bollywood' follows the journey of a young man from Delhi who is full of determination to make a space for himself in cutthroat world of Bollywood.

Across seven episodes, the show dives into the challenges he faces. He experiences the politics, power plays, and glittering yet unforgiving nature of the Hindi film industry.

The series also features Lakshya, Raghav Juyal, Sahher Bamba, Anya Singh, Bobby Deol, Mona Singh, and Manoj Pahwa.

Netflix has not yet publicly responded to the NHRC's notice.

The NHRC has issued notice to the Ministry of Information and Broadcasting and Mumbai police commissioner in the wake of a complaint alleging that web series 'Ba***ds of Bollywood' on an OTT platform, showed a popular actor using banned e-cigarette on screen, "without any warning or disclaimer", according to proceedings of the case.

The complainant has further alleged that this particular scene was "streamed openly", which misled or negatively influenced young viewers by allegedly promoting use of such banned substances, it says.

There was no immediate reaction from the ministry or over-the-top platform Netflix.

The National Human Rights Commission has said that authorities be directed to get the allegations levelled in the complaint, be inquired into, and an "action taken report" be submitted within two weeks for perusal of the Commission.

"The complainant, Vinay Joshi, Legal Rights Observatory, alleged that a popular Netflix web series, titled 'Ba***ds of Bollywood' (season 1, episode 7), showed a well-known actor, Ranbir Kapoor, using a banned e-cigarette on screen, without any warning or disclaimer," reads the proceedings of the case dated September 22.

NHRC member Priyank Kanoongo issues statement

The NHRC has now formally asked the Information and Broadcasting Ministry and Mumbai Police to provide an Action Taken Report. This move could lead to further investigation and possible legal action against the actors, producers, or the streaming platform.

NHRC urgs govt to take appropriate action to prohibit such content

According to ANI, NHRC in its communication to the Information and Broadcasting Ministry, has urged the government to take "appropriate action" to prohibit such content on OTT platforms, citing its potential influence on impressionable audiences, particularly youth.

Separately, the NHRC has written to the Mumbai Police Commissioner, recommending the registration of an FIR against Ranbir Kapoor, the producers, the production company, and Netflix under the Prohibition of Electronic Cigarettes Act, 2019. The law bans the production, sale, and advertisement of e-cigarettes in India.

The complaint, which triggered the NHRC's intervention, claimed that the series promoted the use of banned e-cigarettes without carrying the mandated anti-smoking disclaimers, thereby violating legal and ethical broadcasting norms.

As of now, there has been no official response from Netflix, Ranbir Kapoor, or the production team of the series.

Aryan Khan's directorial debut on Netflix is being liked by critics and audiences alike. An excerpt from the Hindustan Times review reads, "The USP of Ba***ds are not the cameos or the glitz. It is an almost behind-the-scenes look at Bollywood's underbelly. It comes from a man who has grown up watching all this around himself, Aryan Khan. So, there is some amount of credibility to it.



What's happening?

The National Human Rights Commission has stepped in, asking Mumbai Police to register a case against Ranbir Kapoor, the show's producers, and Netflix. The allegation? That the series promoted e-cigarettes in violation of the Prohibition of Electronic Cigarettes Act, 2019. According to the complaint filed by activist Vinay Joshi, Ranbir was shown smoking an e-cigarette without a health warning or disclaimer, which he argued could influence young audiences and normalise banned substances.

The complaint further accused the show of spreading irresponsible content that undermines public health and law enforcement while glorifying an illegal product. Acting on this, the NHRC issued notices to the Ministry of Information and Broadcasting to take immediate action against such depictions. Meanwhile, the Mumbai Police Commissioner has reportedly also been asked to investigate the supply chains of e-cigarettes, and submit a report within two weeks.

The National Human Rights Commission (NHRC) has asked Mumbai Police to register a case against Bollywood actor Ranbir Kapoor, the producers of the web series 'The Ba***ds of Bollywood,' and streaming platform Netflix. The action comes in response to allegations of promoting and depicting e-cigarettes in violation of the Prohibition of Electronic Cigarettes Act, 2019.

Who filed the complaint?

The complaint was filed by activist Vinay Joshi, who informed the Commission that a scene in the show features Ranbir Kapoor using an e-cigarette on screen without any accompanying health warning or statutory disclaimer. According to Joshi, this scene was broadcast publicly and freely accessible, potentially misleading young viewers and glamorizing the use of a banned substance. He emphasised that such portrayals not only promote unlawful behavior but also risk damaging public health, encouraging nicotine addiction, and undermining efforts by authorities to curb the use of harmful products.

The NHRC has taken serious note of these allegations. In its notice, the Commission has asked the Secretary of the Ministry of Information and Broadcasting to take immediate steps to restrict such content that may misguide younger audiences or promote the consumption of prohibited products. The notice urges the ministry to review policies around content regulation on OTT platforms to ensure that legal and moral standards are upheld.

Additionally, the NHRC has directed the Commissioner of Police, Mumbai, to investigate the case thoroughly. The Commission has specifically asked for an inquiry into not only the actors and producers involved but also into the operations and identities of those manufacturing and importing e-cigarettes, which have been banned under Indian law since 2019.

National Human Rights Commission (NHRC) member Priyank Kanoongo says, "We received a complaint from an organisation called the Legal Rights Observatory. The complainant stated that there is a series called "The Ba***ds of Bollywood" on the Netflix OTT platform. In one episode of this series, actor Ranbir Kapoor is smoking an ecigarette. The complainant alleges that through this, he is influencing young people, especially our new generation, to smoke e-cigarettes. We examined this complaint and

found that in India, under the E-Cigarette Prohibition Act, no person shall promote e-cigarettes. Manufacturing, importing, selling, or stocking e-cigarettes in India is a crime.'

The Mumbai Police has been given a two-week deadline to submit an action-taken report detailing the progress of the investigation. The NHRC's swift intervention signals growing concern over the influence of digital entertainment content on public behavior and the responsibility of filmmakers and platforms to adhere to existing legal frameworks.

Notably, 'The Ba***ds of Bollywood*, directed by Aryan Khan, is currently streaming on Netflix. The controversy has reignited debates over content regulation on OTT platforms and the portrayal of substances banned by law.

The National Human Rights Commission has asked Mumbai Police to register a case against actor Ranbir Kapoor, the producers of the web show The Ba***ds of Bollywood, and Netflix for their involvement in the advertisement, depiction, or promotion of ecigarettes in contravention of the Prohibition of Electronic Cigarettes Act, 2019.

In one of the scenes, Ranbir Kapoor is seen smoking an e-cigarette without any warning or disclaimer, complainant Vinay Joshi told the commission.

The complainant further alleged that the scene was streamed openly, which misled or negatively influenced young viewers by promoting the use of such banned substances. The complainant expressed concerns that such irresponsible content promotes illegal activities, disrespects law enforcement, and harms public health and morality.

The commission has issued a notice to the Secretary of the Ministry of Information and Broadcasting, urging appropriate action to immediately prohibit such content that may wrongly influence young generations.

The Commissioner of Police, Mumbai, has been asked to initiate an investigation into the identity and operations of manufacturers and importers of electronic cigarettes.

The Commissioner has given two weeks' time to file the action report with the commission.

MUMBAI: Trouble appears to be mounting for actor Ranbir Kapoor, as the National Human Rights Commission (NHRC) has directed Mumbai Police to register a case against him, the producers of The Ba**ds of Bollywood, and streaming giant Netflix.

According to recent reports, the action follows allegations that the series includes a scene where Kapoor is seen using an e-cigarette without any statutory warning or disclaimer, allegedly in violation of the Prohibition of Electronic Cigarettes Act, 2019.

The Mumbai Police Commissioner has also reportedly been instructed to investigate the involvement of e-cigarette manufacturers and importers linked to the matter.

Authorities have been given a two-week deadline to submit an action report to the Commission.

"Section 4 prohibits the storage, use, and promotion of e-cigarettes in any form, while Section 7 penalises individuals and companies that advertise or promote such banned products," it added.

The National Human Rights Commission (NHRC) has sought responses from the Ministry of Information and Broadcasting and the Mumbai Police over a complaint against Netflix's web series The Bads of Bollywood.

India banned electronic cigarettes in 2019

The complainant argued that the portrayal not only violated existing laws but also contravened health advisories issued by the government regarding the depiction of smoking and tobacco-related products in films and digital content. Current regulations require that any depiction of smoking must carry clear on-screen warnings, anti-smoking disclaimers, and public service announcements to discourage tobacco use.

NHRC seeks responses from Information and Broadcasting Ministry

By seeking an Action Taken Report (ATR), the NHRC has effectively asked the Ministry and the Mumbai Police to examine whether the platform and the makers of the series violated statutory guidelines and if corrective measures are necessary. The Commission has given both authorities a timeline to respond with details of the action initiated, if any.

This is not the first time content on streaming platforms has come under scrutiny in India. Over the past few years, OTT services have faced complaints on grounds ranging from obscenity and religious sensitivities to violations of health and safety regulations. The

The National Human Rights Commission (NHRC) has sought an Action Taken Report from the Information and Broadcasting Ministry and Mumbai Police over a complaint against Netflix's web series 'Ba***ds of Bollywood'. The complainant alleged actor Ranbir Kapoor was shown using a banned e-cigarette without warnings, misleading young viewers.

According to plaintiff Vinay Joshi, Legal Rights Observatory, "Netflix web series, titled 'Bads of Bollywood' (season 1, episode 7), showed a well-known actor, Ranbir Kapoor, using a banned e-cigarette on screen, without any warning or disclaimer."

Joshi further alleged that this scene was streamed openly, which misled or negatively influenced young viewers by promoting the use of such banned substances. He expressed concerns that such irresponsible content promotes illegal activities, disrespects law enforcement, and harms public health and morality. The plaintiff sought the intervention of the commission and requested strict legal action against the actors, producers, and Netflix for violating Indian laws and spreading harmful content.

The Bench of the NHRC, presided by Priyank Kanoongo has taken cognizance u/s 12 of the Protection of Human Rights Act, 1993, in the matter.

Furthermore, this incident is in clear violation of Sections 4 read with Section 7 of the Prohibition of Electronic Cigarettes Act, 2019. It is pertinent to mention here that Section 4 prohibits the storage, use, and promotion of e-cigarettes in any form, and Section 7 penalises individuals and companies that advertise or promote such banned products.

The NHRC has issued a notice to the Secretary of the Ministry of Information and Broadcasting, urging immediate steps to prohibit such content that may wrongly influence the younger generation.

It has also asked the commissioner of police, Mumbai, to investigate the identity and operations of e-cigarette manufacturers and importers linked to the case. The commissioner has been directed to submit an action report within two weeks.

The Ba***ds of Bollywood marks Aryan Khan's first project as a director and creator, cowritten alongside Bilal Siddiqi and Manav Chauhan. The series is set to stream from September 18, 2025 on the streaming giant, Netflix.

The National Human Rights Commission (NHRC) has called on the Mumbai Police to initiate legal proceedings against actor Ranbir Kapoor, producers, the production company, and OTT platform Netflix. This follows allegations of a violation stemming from the depiction of banned e-cigarettes in the show 'The Ba***ds of Bollywood' without any warning or disclaimer.

The controversy erupted after an episode showed Kapoor using a banned e-cigarette, sparking a complaint from the Legal Rights Observatory. NHRC member Priyank Kanoongo has written to the Mumbai Police Commissioner, highlighting the violation of the Prohibition of Electric Cigarettes Act 2019 and urging legal action against the accused parties.

Kanoongo emphasized the illegal nature of promoting e-cigarettes in India, pointing out that manufacturing, importing, selling, or stocking such products is criminalized. He has also pressed the Ministry of Information and Broadcasting to address the issue on the platform and ensure compliance with the country's regulations.

Mumbai (Maharashtra) [India], September 22 (ANI): The National Human Rights Commission (NHRC) urged the Mumbai Police to register an FIR against actor Ranbir Kapoor, producers, production company and OTT platform Netflix for allegedly airing the use of banned e-cigarettes on screen without a warning or disclaimer in the recently show 'The Ba****ds Bollywood.' released of 'The Ba***ds of Bollywood' came under the radar of controversy after an episode featured Ranbir Kapoor allegedly smoking a banned e-cigarette without a warning or disclaimer the screen during its on release. After receiving a complaint regarding the same from the Legal Rights Observatory, the NHRC member Priyank Kanoongo wrote a letter to the Commissioner of Mumbai Police, urging them to take legal action against the actor, production studio and the OTT platform for the violation of the Prohibition of Electric Cigarettes Act 2019. While talking to ANI, Priyank Kanoongo said, "We received a complaint from an organisation called the Legal Rights Observatory. The complainant stated that there is a series called "The Ba***ds of Bollywood" on the Netflix OTT platform. In one episode of this series, actor Ranbir Kapoor is smoking an e-cigarette. The complainant alleges that through this, he is influencing young people, especially our new generation, to smoke ecigarettes."

While calling the promotion, manufacturing, importing, selling or stocking e-cigarettes a crime, Priyank Kanoongo said that they have issued a letter to the Secretary of the Ministry of Information and Broadcasting, urging him to "remove this and take action against the relevant platforms." "We examined this complaint and found that in India, under the E-Cigarette Prohibition Act, no person shall promote e-cigarettes. Manufacturing, importing, selling, or stocking e-cigarettes in India is a crime. We have issued a notice to the Commissioner of Mumbai Police. We have asked him to file an FIR under the appropriate sections and take legal action against this actor, this production company, and this OTT platform. We have also asked him to identify the manufacturers, importers, stockists, and sellers of these ecigarettes and take appropriate legal action against them. We have also issued a notice to the Secretary of the Ministry of Information and Broadcasting, asking him to remove this and take action against the relevant platforms," said Privank Kanoongo.

'The Ba***ds of Bollywood' was directed by Aryan Khan and stars Lakshya, Raghav Juyal, Bobby Deol and Sahher Bambba in the lead roles. The show is currently streaming on Netflix. (ANI)

The National Human Rights Commission (NHRC) has urged the Mumbai Police to file a case against actor Ranbir Kapoor, the producers of the web series 'The Ba**ds of Bollywood', and streaming giant Netflix for allegedly promoting electronic cigarettes in violation of the Prohibition of Electronic Cigarettes Act, 2019.

The complaint, filed by Vinay Joshi, pointed out that Kapoor was shown smoking an ecigarette in one of the scenes of the show without any statutory warning or disclaimer. According to Joshi, such depictions glamorize vaping and risk influencing young viewers.

NHRC Issues Notice

Acting on the complaint, the NHRC issued a notice to the Secretary, Ministry of Information and Broadcasting, asking the ministry to take immediate steps to curb the promotion of e-cigarettes on streaming platforms. The commission emphasised that unchecked portrayal of such content can have damaging effects on impressionable audiences, particularly the youth.

Police Told to Investigate

The commission has also directed the Commissioner of Police, Mumbai, to investigate the case thoroughly. This includes probing the identity and operations of manufacturers and importers of e-cigarettes, which are banned under Indian law. The police have been asked to submit a detailed report following the inquiry.

Content Under Scrutiny

With the NHRC's intervention, the matter has placed streaming platforms and film producers under closer watch for compliance with laws governing public health. The development adds to ongoing debates over the responsibility of OTT platforms in curating content that could potentially mislead viewers.

The film is a two-part live-action saga set 5,000 years ago and rooted in one of Indian mythology's most enduring epics.

नयी दिल्ली, 22 सितंबर (भाषा) राष्ट्रीय मानवाधिकार आयोग (एनएचआरसी) ने उस शिकायत के मद्देनजर सूचना एवं प्रसारण मंत्रालय और मुंबई पुलिस आयुक्त को नोटिस जारी किया है, जिसमें आरोप लगाया गया है कि एक ओटीटी मंच पर जारी वेब सीरीज 'बैड्स ऑफ बॉलीवुड' में एक लोकप्रिय अभिनेता को बिना किसी चेतावनी या अस्वीकरण के प्रतिबंधित ई-सिगरेट का इस्तेमाल करते हुए दिखाया गया है।

राष्ट्रीय मानवाधिकार आयोग ने कहा है कि अधिकारियों को निर्देश दिया जाए कि वे शिकायत में लगाए गए आरोपों की जांच करें और आयोग के अवलोकन के लिए दो सप्ताह के भीतर कार्रवाई रिपोर्ट प्रस्तुत करें।

यह शिकायत मानवाधिकार कार्यकर्ता विनय जोशी ने दर्ज कराई है। आरोप है कि नेटफ्लिक्स की वेब सीरीज 'बैड्स ऑफ बॉलीवुड' में जाने-माने अभिनेता रणबीर कपूर को बिना किसी चेतावनी या अस्वीकरण के प्रतिबंधित ई-सिगरेट का इस्तेमाल करते हुए दिखाया गया है।

एनएचआरसी ने कहा कि शिकायत में लगाए गए आरोप प्रथम दृष्ट्या कानूनों का गंभीर उल्लंघन प्रतीत होते हैं।

22 सितंबर 2025 को भेजे गए इस नोटिस के बारे में बात करते हुए NHRC के सदस्य प्रियांक कानूनगो ने बताया कि उन्होंने इस सीन को लेकर रणबीर कपूर के साथ साथ प्रोडक्शन हाउस और नेटिफ्लक्स के खिलाफ भी मामला दर्ज करने की अपील की है। फिल्म में बिना किसी चेतावनी या डिस्क्लेमर के ई-सिगरेट का इस्तेमाल दिखाया गया जिसे लेकर NHRC ने सूचना और प्रसारण मंत्रालय के सचिव को भी पत्र लिखा है। इस पत्र में सीरीज के इस सीन पर रोक लगाने की मांग की गई है।

NHRC को फिल्म के सीन के खिलाफ मिली थी शिकायत

NHRC सदस्य प्रियांक ने कहा- हमें लीगल राइट्स ऑब्जर्वेटरी नाम की एक ऑर्गनाइजेशन ने हमें सीरीज के खिलाफ शिकायत की है। इसमें बताया गया है कि नेटफ्लिक्स ओटीटी प्लेटफॉर्म पर चल रही 'द बैड्स ऑफ बॉलीवुड' सीरिज के एक एपिसोड में एक्टर रणबीर कपूर ई-सिगरेट पीते हुए दिखाई दे रहे हैं। इस शिकायत में आरोप लगाया गया कि यह सीन युवाओं को ई-सिगरेट पीने के लिए इंस्पायर कर रहा है। इस शिकायत की हमने जांच की और पाया कि भारत में ई-सिगरेट निषेध अधिनियम के तहत, कोई भी शख्स ई-सिगरेट को प्रमोट नहीं कर सकता है। जिसके बाद हमने मुंबई पुलिस किमशनर को इस मामले में एक नोटिस जारी किया।

शिकायत और कार्रवाई की मांग

एनएचआरसी के सदस्य प्रियांक कानूनगों ने बताया कि एक संस्था की ओर से शिकायत दर्ज कराई गई थी. शिकायतकर्ता का आरोप है कि इस सीन के जिरए युवाओं, खासकर नई पीढ़ी को ई-सिगरेट की लत के लिए प्रेरित किया जा रहा है. जांच के बाद आयोग ने पाया कि भारत में ई-सिगरेट का निर्माण, आयात, बिक्री और प्रचार पूरी तरह प्रतिबंधित है.

इसी आधार पर आयोग ने मुंबई पुलिस किमश्नर को नोटिस जारी किया है. इसमें अभिनेता, प्रोडक्शन कंपनी और नेटिफ्लिक्स प्लेटफॉर्म के खिलाफ एफआईआर दर्ज कर कानूनी कार्रवाई करने को कहा गया है. साथ ही, ई-सिगरेट के निर्माण और बिक्री से जुड़े लोगों पर भी कार्रवाई की सिफारिश की गई है.

मंत्रालय को भी नोटिस

प्रियांक कानूनगों ने बताया कि सूचना एवं प्रसारण मंत्रालय को भी नोटिस भेजा गया है. मंत्रालय के सचिव से अनुरोध किया गया है कि विवादित दृश्य को तुरंत हटाया जाए और संबंधित प्लेटफॉर्म के खिलाफ कड़ा कदम उठाया जाए.
