Dear

The National Human Rights Commission, in its Full Commission meeting, held on 31st October, 2022 discussed the problems of deaths of manual scavengers/sanitary workers, involved in hazardous cleaning, in various parts of the country. In view of many deaths of the persons employed in hazardous cleaning of septic tanks/pits, sans safety gear/protective measures, reported attempts to suppress the incidents, and intending to complete eradication of the dehumanizing practice, the Commission has taken a view that a direction should be issued forthwith to all the local Governments, Municipal Corporations and District Magistrates of every district of the country that they should report to the Secretary General of the Commission about such incidents of death due to hazardous cleaning, within 48 hours of such occurrence or the information received thereto by the public servant or intimation received from any member of the public/society. Failure to report promptly would give rise to a presumption that there would be an attempt to suppress such incidents.

It is accordingly requested that Heads of local bodies/Municipal Corporations/Maha Nagar Nigams and District Magistrates of every district may be given suitable instructions, in this regard, so as to ensure prompt communication of the incident of deaths related to hazardous cleaning. The report must also contain, qua, the responsibility and accountability of the concerned authorities, who have failed to ensure proper protective gear, safety equipments for the sanitary workers/persons employed in hazardous cleaning. The report may be submitted as per the prescribed proforma (enclosed).

The report may be referred/intimated to the Commission, preferably online mode, through HRCNet Portal. The manner of uploading the information has already been communicated vide our D.O. letter dated 21st October, 2022.
