### COLLABORATIVE TRAINING PROGRAMME WITH NATIONAL HUMAN RIGHTS COMMISSION

The National Human Rights Commission invites proposals for conducting collaborative training programme with National Human Rights Commission (NHRC) for One Day/Two Days/Three Days in Human Rights from Academic Institutes like Universities, Colleges, Administrative Training Institutions (ATIs)/Police Training Institutes (PTIs)/Judicial Training Institutes (JTIs)/NGO's/SHRCs etc. for the financial year 2021-22. Institutes are requested to submit their proposal for conducting the programme **for the Q/E September 2021 latest by 30 July 2021 and for the Q/E Dec 2021 latest by 31<sup>st</sup> October 2021 and for the last quarter i.e. March 2022 latest by 31 December 2021.**

2. National Human Rights Commission collaborates by way of financial assistance to the Institutes/Organisations and provides the template for conducting such trainings. The Training guidelines of NHRC will be strictly adhered to in all respect.

3. The financial/funding rules applicable to such programmes would be in line with the general financial/funding rules applicable to all training programmes as described below:-

**For Training Programme to be conducted ONLINE mode;**

Keeping in view the present pandemic situation, it has been decided by the Commission to permit the institutions/organizations to do Training Programme on online platform. The budget and other conditions of the Online Training Programme would be as under:-

4. The above grants will be provided subject to the conditions that
- i) All payments by the Institutions/Organizations to the Resource Persons and Participants of the Human Rights Training Programme will be made by ECS only, and, a proof of which would be provided by the Institutions/Organizations to the Commission at the time of submission of Utilization Certificate/ Settlement.
  - ii) The above grant is for One Day Training Programme only.
  - iii) This above Online Training Programme will be applicable in the Pandemic period declared by the Government or in any unforeseen exigency, for which prior approval of the Commission would be required.
  - iv) The institution/organization shall provide the link to the person designated by the Commission to attend the programme from NHRC side well in advance.
  - v) Since in Online Training Programme the Institutions/Organizations would utilize their own network system thus contribution of Institutions/Organizations towards Human Rights Training Programme has not been placed.

All other conditions of the Training Guidelines of the Commission will remain same.
