2- The Core Group will also include special invitees (up to 5) with approval of the Chair depending upon the specific agenda to be discussed in the Core Group meeting.


3- The Terms of Reference for the Core Group on Older Persons is as under:

- i. To advise the Commission on issues relating to the rights of Older Persons. These issues may include the reference made by the Commission to the Core Group, and any other issue, which the members of the Core Group would consider appropriate to suggest to the Commission in light of the relevant provisions of the Protection of Human Rights Act, 1993.
- ii. To review the existing government policies, laws, rules, orders, etc., relating to the Older Persons from the perspective of human rights and make suggestions/recommendations for change or for their better implementation.
- iii. To identify best practices, policies and programs nationally and internationally adopted to protect the rights of Older Persons.

4- The Core Group will meet periodically at regular intervals as and when deemed necessary.

5- The participating members of the Core Group shall be entitled to an honorarium of Rs. 2,000/- (Rupees Two Thousand Only) and local transportation of Rs. 1,000/- (Rupees One Thousand Only). The members outside Delhi shall also be entitled for reimbursement of the economy class air fare for the to-&-fro journey undertaken by them to attend the Core Group meetings.
