  - i. to review the existing government policies, laws/rules/orders etc. and other material from human rights perspective and make an assessment of current status of enforcement of the rights of the elderly in different states/UT's in India:
  - ii. to identify voids and gaps in the policy framework for implementation and to suggest measures to fill the same;
  - iii. to identify the important human rights issues concerning the elderly and persons with disabilities and to suggest measures as appropriate for better protection of their rights;
  - iv. to suggest a plan of action for enforcement of rights of elderly and persons with disabilities:
  - v. to examine the best practices in India and abroad dealing with the care of elderly and persons with disabilities;
  - vi. to advice the Commission on implementation of rights mentioned in the Convention on Rights of Persons with Disabilities (CRPD) and gaps in implementation, if any, from time to time;
  - vii. to study the functioning of focal points/coordination mechanism set up by Centre and States and to suggest improvements to the Commission for greater effectiveness;

- viii. to monitor recommendations made by NHRC since 1993 for protection and promotion of human rights of persons with disabilities and elderly persons.
- 2. The Core Group will meet as and when deemed necessary, in the Commission.
- 3. The participating Members of the Core Group shall be entitled for an honorarium of Rs. 2000/- and local transportation of Rs. 1000/-. The Members based outside Delhi shall also be entitled for reimbursement of economy class Air Fare (by Air India) for the to and fro journey undertaken by them in connection with the Core Group meetings.
