- ii) To identify voids and gaps in the policy framework for implementation and suggest measures to fill the same.
- iii) To identify important human rights issues concerning the elderly and to suggest measures as appropriate for better protection of their rights.
- iv) To suggest plan of action for enforcement of rights of elderly persons.
- v) To examine best practices in India and abroad dealing with the care of elderly.
- vi) Any other issue which is considered relevant to the subject by the Group.

3. The Core Group will meet as and when deemed necessary, in the Commission, at the convenience of the Members.

4. The participating members of the Core Group stationed outside Delhi shall be entitled for TA/DA for the journeys undertaken by them in connection with the Core Group meetings as per the norms approved by the Commission.
