

DISTRICT JAIL, TURA, MEGHALAYA

1. **Date of Visit:** I visited Tura District Jail on May 19, 2014. I was accompanied by Shri. J.J. Sangma, Superintendent, District Jail, Tura. The Jailer, Smt. Falicita Wallang, was on leave.
2. **Introduction:** This Jail was last visited by Smt. Roshan Warjri, Minister (Home, Etc.) in October 2013. Earlier to that, Shri. F.D. Sangma, IPS, IG (Prison) visited the jail on 11/07/2013 while Shri. M.K. Sangma, MPS, AIG (Prison) visited on 23/03/2013. This Visitors' Book is from 2008 onwards only. The Superintendent could not produce any earlier one, one which contained my Inspection Note when I was IG (Prison) during the years 1999–2000.
3. **Prison Population:** The total capacity of this Jail is 200 (M-190; F-10). Today, there are 245 inmates (M-234; F-11). This indicates overcrowding and is an **encroachment on the human rights of the inmates**. A certain amount of decongestion can be brought about if the cell adjacent to where the convicts are lodged is made secure and some of the inmates shifted there. A similar process may be initiated at the defunct - but large - Hospital Ward.

It may be mentioned that inmates of different adjoining districts are lodged here. The districts are:

In other words, out of 245 inmates **only 25 are Convicts**, while the rest **220 are UTPs**. A further classification of these UTPs is those facing trial after a Charge-Sheet has been filed in a court of law by the police and those whose cases are still under investigation by the police at the police station level.

4. Staff: One post each of Asst. Jailer and of Craft Instructor is vacant. The post of Asst. Jailer felt vacant following the unfortunate shooting down by militants of Neil Warjri, Asst. Jailer, who was deputed to Williamnagar Jail from Tura Jail for a few days.

The Superintendent informs me that there are only 16 warders to guard the 245 inmates here. It appears that DG, Prisons cannot appoint any warders on leave vacancy as the proposal has to go to Government for sanction. By the time Government responds, the leave period is almost over. This appears to be a great security risk.

5. Land and Building: The area of the jail complex is 85 bighas. There is a high wall enclosing the entire jail complex. The outer perimeter wall was raised by 5 feet recently, making it an 8 feet wall. Similarly, the inner perimeter wall was raised by 5 feet making it a total of 20 feet. Further, the main gate is under construction following the orders of the Home Minister during her visit to this jail in October last year. The Interview and Waiting Room facilities are attached to the Main Gate.

A total of 4 Watch Towers also exist. An Armed Branch component from 2nd MLP Bn, Goeragre, man these watch towers.

There are 6 wards in this jail and an enclosed Female Ward to house the female UTPs. The break-up in the wards is as follows:

There are colour TVs in the cells. Some of them need repairs.



- 6. Sanitation:** The overall sanitary condition in the jail premises is satisfactory. There are two sanctioned posts of sweepers.
- 7. Food and Kitchen:** Firewood is still being used in the kitchen. However, the Superintendent informs me that within a month, firewood will be replaced by gas as all formalities for this change have been effected.
- 8. Clothing and Bedding:** There are no uniforms for the 25 convicts who are supposed to wear a convict's uniforms as per Rule 235 of the 'Rules for Management of Jails in Assam' contained in 'Assam Jail Rules' Part III made under the Prisoners Act, 1894 (Annexure 'C'). Also, the jail staff is without uniform.
- 9. Education:** Earlier, a UTP was holding classes for the inmates inside the Jail. After he secured bail, no more classes were held. The current situation is that though a few inmates are willing to teach, the rest are unwilling to learn. A certain amount of counselling may help matters here.
- 10. Prison Industries:** Though cane, bamboo and carpentry facilities are available here, the inmates are unwilling to work. Also, the Craft Instructor posted here passed away last year. A new one is yet to be appointed. **This disinclination and lethargy on the part of the inmates may spring from a sense of despair and despondency.**
- 11. Interviews:** This facility is granted to the inmates 2 to 3 times a week. In the absence of a regular interview room, the Inmates meet their relatives and friends at the gate itself for 10-odd minutes. The situation may improve once the main gate and connected facilities are constructed.
- 12. Correctional programme:** There is no Counsellor in this district jail. This need to be righted immediately as a sense of wretchedness prevails amongst the inmates here. This gloom may be lifted through persistence counselling by a professional counsellor.
- The Recreational-cum-Library Hall is used by various denominations to hold service every Sunday. This is done by the Baptist Church, the Catholic Church and the Charismatic Church (Benny Hill).
- 13. Recreational Activities:** Indoor and outdoor games like chess, ludo, carom, volley-ball, are available for both male and female inmates.
- 14. Health and Hospital:** The Hospital Ward is lying empty as the hospital has been shifted to the workshop area where security is provided by the warders. To ease congestion in the other wards, this hospital ward may also be made secure and some inmates shifted here.
- Dr. Brij Chandra Paul, along with one compounder and 2 male attendants, are present in this jail. The doctor feels handicapped while treating female inmates owing to the absence of a female attendant.

Serious cases are referred to Civil Hospital Tura or to the North East Indira Gandhi Regional Institute of Health and Medical Sciences (NEIGRIHMS), Shillong.

Free medicines are provided by the National Rural Health Mission (NRHM) and by the Director Health Services (DHS). Those medicine which were not available either with the NRHM or the DHS, are bought from Government-approved firms in the open market.

There are 3 mental cases, all UTPs. All are serious cases and need immediate shifting to the Meghalaya Institute of Mental Health & Neurological Science (MIMHANS). These are:

1. Jakamish Ch. Marak – 19 years – Ampati C/No. 54(II) u/s 302 IPC (Admitted on 17/12/2010). Requires review after 15 days at MIMHANS, Shillong (22/2/2014).
2. Bishnu Kundu – 28 years – Mahindraganj PS C/No. 27(12) u/s 395 IPC (Admitted on 04/01/2013). Reference to a psychiatrist is a must.
3. Ruhalo Haque – 58 years – Dalu PS C/No. Non FIR 17/Pt.III/13 u/s 12(a) IPP Act. (Admitted on 23/09/2013). Reference to a psychiatrist is a must.

The details are at **Annexure 'D', 'E', and 'F'**.

15. Remission: Remission is practised in the jail as per the norms contained in **Annexure 'G'**.

16. Leave and Parole: This is being practiced here.

17. Pre-mature Release: This is being practiced here.

18. Status of Investigation and Trial pending against UTPs:

The 206 UTPs lodged here have a total of 236 cases pending against them. This mismatch in the figure is due to the fact that some UTPs may figure in 2 cases of 2 different courts. The break up is as follows:

1. Bagmara	-	41
2. Resubelpara	-	40
3. Ampati	-	22

There appears to be a strong need to appeal to the Magistrates concerned to release those inmates who are behind bars for over 90 days as per provisions of 167 CrPC. This would not only look after the human rights of these inmates but would also de-congest this jail.

19. Appeal: There are no appeals pending.

20. Legal aids for inmates: The Legal Aids Cell inside the jail is non-functional as the lawyer deputed here has not visited the jail at all. The Cell is supposed to function every Saturday. Many applications have been received from the inmates for legal aid and these have been duly forwarded to the concerned authorities. However, there appears to be no response from the Meghalaya State Legal Services Authority (MSLSA).

Almost all the inmates who interacted with me complained that the advocates assigned to them by the Meghalaya State Legal Services Authority did not meet them. This is a **gross human rights violation** as these indigent inmates have no one else to turn to for legal redressal of their grievances.

Their details are at **Annexure 'H'**.

21. Board of Visitors: The Board of Visitors for the 4 Jails of Meghalaya was notified by the Government on July 24, 2012. The last visit to this jail was on 27/11/2013. Also, the Under Trail Review Committee, notified by the Government on March 9, 2012 for the 4 District Jails, does not appear to have met at all. Photo copy of this Notification is at **Annexure 'I'**.

22. Departmental Inspections: The Inspection Register has been mixed up with the Visitors' Book. Rule 11 and Rule 12 of the 'Rules for Management of Jails in Assam', contained in 'Assam Jail Rules' Part III made under the Prisoners Act, 1894, contain instructions regarding Inspections of jails by the Inspector-General and its transmission to the Superintendent of the concerned jail (**Annexure 'J'**).

23. Interaction with inmates: Most of the inmates I interacted with had just one complaint – their appointed advocates seldom met them.

24. Summary and Recommendations:

1. The over-crowding in this jail is a matter of serious concern and a gross human rights violation. Steps to de-congest this jail could be undertaken by fortifying one Cell attached to the Segregation Ward and the abandoned Hospital Ward.
2. The cases of the 220 UTPs may be expedited, especially those which are pending for investigation by the police.
3. The posts of Asst. Jailer and of the Craft Instructor may be filled up on a priority basis. Also, only 16 Warders to look after 245 inmates, appears to be an inadequate number. Owing to this insufficient number of warders, the inmates are crammed in small cells.
4. Convicts may be issued their proper uniforms. This applies to the jail staff also, as all of them are without any uniform.
5. The construction of the Main Gate, the Interview room and of the Waiting room may be expedited.

6. There is a need for female medical attendant and of a female nurse here.
8. A post of a Counsellor may be created as the inmates have no one to counsel them. This may explain their diffidence towards attending classes or doing some creative work, like cane and bamboo work.
9. The 3 mental cases need immediate shifting to the Meghalaya Institute of Mental Health & Neurological Science (MIMHANS). They are Jakamish Ch. Marak, Bishnu Kundu and Ruhalo Haque.
10. Meghalaya State Legal Services Authority may play a more positive role in alleviating the condition of the UTPs.

ABSTRACT OF REMISSION RULES.

I.—ORDINARY REMISSION.

1. Government has ordered that all eligible prisoners who behave themselves and perform their task shall be granted remission of sentence, as follows—

To ordinary prisoners	... 4 days' remission in every month.
To Convict Night Watchmen	5 days' " "
To Convict Overseers	6 days' " "
To Convict Warders	8 days' " "

2. Prisoners who work on Sundays and holidays may be awarded any extra 3 days' remission in each quarter.

3. But no ordinary remission will be granted for the month in which a prisoner is admitted to, or released from, jail.

4. Any prisoner who does no work for one calendar month will be eligible for only two days' remission for that month.

5. Every prisoner who is not punished for a prison offence for one whole year from the 1st day of the month following the date of his sentence or the date on which he was last punished for a prison offence, shall be awarded 15 days' remission in addition to any other remission earned.

II.—SPECIAL REMISSION.

6. Special remission may be awarded for special services, as for example—

- (1) Assisting in detecting or preventing breaches of prison discipline or regulations;
- (2) Success in teaching handicrafts;
- (3) Special excellence in, or greatly increased output of, work of good quality;
- (4) Protecting an officer of the prison from attack;
- (5) Assisting an officer of the prison in the case of outbreak, fire or similar emergency;
- (6) Economy in wearing clothes.

7. 30 days' remission is equal to one month's remission.

The functions and powers of the Board of Visitors are as follow:-

1. The Board of visitors shall pay a joint visit of inspection to the Jail, every quarter. At each quarterly meeting of the Board, The Chairman shall draw up a roster of visits to be paid by each visitor during the next three months. This roster should ordinarily be drawn up so as to provide for fortnightly visits, but if any Board expresses a desire for weekly visits the Chairman should arrange accordingly. Save in exceptional circumstances, visitors shall not visit the jail after lock up or Sundays. Visitors shall not ordinarily visit the jail on jail/holidays but if considered necessary permission to do so may be accorded at the discretion of the jail Superintendent.
2. It is the duty of the visitor to satisfy himself that the law and rules regarding the management of prisons and prisoners are duly carried out in the jail, to visit all parts of the jail and to see all prisoners and to hear and enquire into any complaint that any prisoner may make.
3. A visitor may call for and inspect any book or other record in the jail, provided that the Superintendent may decline to produce any book, paper or record for inspection if, for reasons to be recorded in writing, he considers such production undesirable.
4. The Board of visitors shall meet at the Jail, inspect all building and prisoners, hear any complaints and petitions that may be preferred, inspect the prisoner's foods and see it is of good quality and properly cooked, examine the punishment book and satisfy themselves that it is up to date and that punishments awarded are in accordance with the rule, and scrutinize any case of long detention of under trial prisoners.

Extract of Rules 11 and 12 of the 'Rules for Management of Jails in Assam' contained in 'Assam Jail Rules' Part III made under the Prisoners Act, 1894

11. **Inspection of jails by Inspector-General** – (1) He shall inspect all departments of every jail at district headquarters and at Shillong at least once a year and of every jail at sub-divisional headquarters and at Tura, Kohima and Aijal at least once in two years.

(2) During each inspection he shall personally see every prisoner then in confinement in the jail, he shall give every prisoner a reasonable opportunity of making any application or complaint and shall investigate and dispose of such as relate to jail discipline.

(3) He shall inspect the yards, wards, cells, worksheds, and other enclosures, shall examine the garden, enquire into the character of the water-supply, the conservancy arrangements, and the medical administration, shall see the food and ascertain that it is of proper quality and quantity, and generally satisfy himself that the building and premises are in proper order.

(4) He shall inspect all journals, registers and books maintained in every department of the jail, and initial or countersign them in token that he is satisfied that they are maintained in accordance with rules. He shall satisfy himself that the orders of Government regarding the arrangement and periodic destruction of records are observed.

(5) He shall inspect the warder establishment, satisfy himself as to its proficiency in drill and musketry, inspect its arms and accoutrements, and test the ability of each jail officer of the upper subordinate establishment to drill the guard.

12. **Memorandum of inspection to be supplied to Superintendent** – Immediately after the inspection the Inspector-General shall furnish the Superintendent with a memorandum embodying his opinion of the manner in which the jail is administered, the extent to which the officers appear familiar with their duties, together with any suggestions or order for the guidance of the Superintendent.
